Solarstone Limited was founded in 2018 as an Ohio Limited Liability Company. The proper documents were filed with the Ohio Secretary of State on 6/15/2018. The company was founded in order to broker and aggregate residential electricity in the retail electricity markets in Ohio. The primary interest of the business is to engage in commercial activity related to electricity at the level of the end user.

As a single member LLC incorporated in Ohio this exhibit is not applicable.

Solarstone Limited is not currently filing for, certified, licensed, registered, or otherwise authorized to provide retail or wholesale electric services including aggregation services in any other jurisdiction other than the current application being submitted to the Public Utilities Commission of Ohio.

Exhibit B-2 "Experience & Plans"

Solarstone Limited plans to conduct business with customers according to Section 4928.10 of the Ohio Revised Code. The applicable code has been provided in **Appendix B** "Minimum Service Requirements for Competitive Services" for reference.

In summary, Solarstone will disclose the appropriate price per watt of electricity in the bill provided to the customer. The contract will disclose pricing, terms and conditions of service, as well as any fees related to switching or failures to uphold the contract. Disclosure in the contract will also provide conditions under which the customer can remove themselves from the contract without penalty, including provisions for service termination and the related penalties or notices involved.

The minimum content of bills provided to customers will include standardized statements for billing period, units, and annual electricity usage. The bill will be broken into appropriate service periods and units in order for the customer to recalculate balances provided in the bill. Suppliers of electricity services will subsequently be identified and disclosed in order to aid convenience and accuracy. A standardized statement for payment is as follows:

"Payment may be made by check, credit card, or ACH made out to 'Solarstone Limited' located at (billing address)."

A standardized statement for toll free customer service is as follows:

"Inquiries can be made by phone between the hours of 9 am to 5 pm at the following number: (business phone)."

State agency phone number listings will also be included as follows:

"PUCO - (800) 686-7826"

"Ohio Attorney General's Office - (614)-466-4986"

Penalties for early termination will be disclosed. Additionally, the energy mix, including the environmental impact and usage breakdown will be included for the benefit of the customer. The generation mix will be disclosed annually and will be provided before renewal of any contract.

Exhibit B-3 "Summary of Experience"

Dan Cook, CEO of Solarstone was a series 3 licensed commodities risk manager at Black Hawk Resources for one year (see resume provided in **Appendix C**). At Black Hawk Resources Ltd., Dan brokered electricity and natural gas for commercial clients in Cincinnati (via Duke Energy) and Chicago. The customers included a steel rebar manufacturer and a primary/secondary steel mill. Both clients were in the PJM interconnection. The exact load of electricity brokered cannot be recalled. At the scale of usage, annual energy bills were in excess of ~\$250,000. Black Hawk Resource Ltd. Is a registered aggregator and

broker in the State of Ohio and Dan has familiarity with both pricing and brokerage with generators and distributors in the deregulated markets in Ohio and other areas of the PJM interconnection. Please see attachments in **Appendix C** for reference to past experience and employer credential.

Solarstone Limited will not be taking title to any electricity. The purpose of this application is for aggregation and brokering only.

Exhibit C-5 "Forecasted Financial Statements"

Please see Table 1 below for 2019 and 2020 projections.

The income statements for 2019 include assumptions of \$.10/kwh average electricity price at the retail level. With household usage of 12,000 kwh/year and a fee structure of 10%, commissions received total \$120 annually per household. Within this structure roughly 50 households are required to participate to achieve retail revenue projections of \$6,000. At the commercial level, with rate assumptions of \$.07/kwh and 12,000 kwh/month capacity per account, at a 10% commission structure, projected revenue received is \$14,112 spread across 14 commercial customers. Assumptions for usage between residential and commercial accounts is expected to be mixed between 70% commercial and 30% residential in the first year. Net income for the year is projected at \$4,978.

2020 assumptions include developed sales support, on a commission basis of 30%, in order to increase revenue. Pricing assumptions per kwh remain the same throughout the year. The mix of accounts will shift to 40% residential by the end of year 2, with an increase in usage across roughly 300 households responsible for \$36,000 in annual revenue. A mix of 40% residential and 60% commercial is projected with commercial customers totaling roughly 64 accounts responsible for \$64,512 in revenue. Net income for the year is projected at \$26,358.

In both years, rent remains constant at \$500/month including facilities for administrative support for 2-3 individuals. Income tax assumptions were factored in at a rate of 30%. Marketing costs will continue to rise as territory expansion develops.

"Minimum Service Requirements

For Competitive Services"

4928.10 Minimum service requirements for competitive services.

For the protection of consumers in this state, the public utilities commission shall adopt rules under division (A) of section <u>4928.06</u> of the Revised Code specifying the necessary minimum service requirements, on or after the starting date of competitive retail electric service, of an electric utility, electric services company, electric cooperative, or governmental aggregator subject to certification under section <u>4928.08</u> of the Revised Code regarding the provision directly or through its billing and collection agent of competitive retail electric services for which it is subject to certification. Rules adopted under this section shall include a prohibition against unfair, deceptive, and unconscionable acts and practices in the marketing, solicitation, and sale of such a competitive retail electric service and in the administration of any contract for service, and also shall include additional consumer protections concerning all of the following:

- (A) Contract disclosure. The rules shall include requirements that an electric utility, electric services company, electric cooperative, or governmental aggregator subject to certification under section 4928.08 of the Revised Code do both of the following:
- (1) Provide consumers with adequate, accurate, and understandable pricing and terms and conditions of service, including any switching fees, and with a document containing the terms and conditions of pricing and service before the consumer enters into the contract for service;
- (2) Disclose the conditions under which a customer may rescind a contract without penalty.
- (B) Service termination. The rules shall include disclosure of the terms identifying how customers may switch or terminate service, including any required notice and any penalties.
- (C) Minimum content of customer bills. The rules shall include all of the following requirements, which shall be standardized:
- (1) Price disclosure and disclosures of total billing units for the billing period and historical annual usage;
- (2) To the maximum extent practicable, separate listing of each service component to enable a customer to recalculate its bill for accuracy;
- (3) Identification of the supplier of each service;
- (4) Statement of where and how payment may be made and provision of a toll-free or local customer assistance and complaint number for the electric utility, electric services company, electric cooperative, or governmental aggregator, as well as a consumer assistance telephone number or numbers for state agencies, such as the commission, the office of the consumers' counsel, and the attorney general's office, with the available hours noted;
- (5) Other than for the first billing after the starting date of competitive retail electric service, highlighting and clear explanation on each customer bill, for two consecutive billing periods, of any changes in the rates, terms, and conditions of service.
- (D) Disconnection and service termination, including requirements with respect to master-metered buildings. The rules shall include policies and procedures that are consistent with sections 4933.121 and 4933.122 of the Revised Code and the commission's rules adopted under those sections, and that provide for all of the following:

- (1) Coordination between suppliers for the purpose of maintaining service;
- (2) The allocation of partial payments between suppliers when service components are jointly billed;
- (3) A prohibition against blocking, or authorizing the blocking of, customer access to a noncompetitive retail electric service when a customer is delinquent in payments to the electric utility or electric services company for a competitive retail electric service;
- (4) A prohibition against switching, or authorizing the switching of, a customer's supplier of competitive retail electric service without the prior consent of the customer in accordance with appropriate confirmation practices, which may include independent, third-party verification procedures.
- (5) A requirement of disclosure of the conditions under which a customer may rescind a decision to switch its supplier without penalty;
- (6) Specification of any required notice and any penalty for early termination of contract.
- (E) Minimum service quality, safety, and reliability. However, service quality, safety, and reliability requirements for electric generation service shall be determined primarily through market expectations and contractual relationships.
- (F) Generation resource mix and environmental characteristics of power supplies. The rules shall include requirements for determination of the approximate generation resource mix and environmental characteristics of the power supplies and disclosure to the customer prior to the customer entering into a contract to purchase and four times per year under the contract. The rules also shall require that the electric utility, electric services company, electric cooperative, or governmental aggregator provide, or cause its billing and collection agent to provide, a customer with standardized information comparing the projected, with the actual and verifiable, resource mix and environmental characteristics. This disclosure shall occur not less than annually or not less than once during the contract period if the contract period is less than one year, and prior to any renewal of a contract.
- (G) Customer information. The rules shall include requirements that the electric utility, electric services company, electric cooperative, or governmental aggregator make generic customer load pattern information available to other electric light companies on a comparable and nondiscriminatory basis, and make customer-specific information available to other electric light companies on a comparable and nondiscriminatory basis unless, as to customer-specific information, the customer objects. The rules shall ensure that each such utility, company, cooperative, or aggregator provide clear and frequent notice to its customers of the right to object and of applicable procedures. The rules shall establish the exact language that shall be used in all such notices.
