MOTION TO INTERVENE OF INDUSTRIAL ENERGY USERS-OHIO

Industrial Energy Users-Ohio ("IEU-Ohio") hereby respectfully moves the Public Utilities Commission of Ohio ("Commission"), pursuant to R.C. 4903.221 and Rule 4901-1-11, Ohio Administrative Code, for leave to intervene in the above-captioned matters with the full powers and rights granted by the Commission, specifically by statute or by the provisions of the Ohio Administrative Code, to intervening parties.

On October 24, 2018, the Commission issued an Entry establishing a PowerForward Collaborative, as well as two workgroups, the Distribution System Planning Workgroup ("PWG") and the Data and Modern Grid Workgroup ("DWG"). This proceeding, the PWG, is intended to identify issues that currently exist, or that may arise, in the integrated distribution planning process. The issues addressed in this proceeding could ultimately affect the price, terms, and conditions upon which IEU-Ohio members receive retail electric service.
