Re: Duke Energy Winton Road Station, Hamilton County, Finneytown, Ohio

This letter is in response to correspondence received on September 17, 2018 (sent September 14, 2018) regarding Duke Energy Winton Road Station Project. My comments are in accordance to Section 106 of the National Historic Preservation Act of 1966, as amended, and the associated regulations at 36 CFR Part 800.

The project consists of the replacement of the Center Hill regulator station and the installation of approximately 1500' of 20-inch pipeline. A report was included with the correspondence, *A Phase I Cultural Resources Survey for The Proposed Duke-Winton Road Natural Gas Pipeline in Cincinnati, Hamilton County, Ohio* (Jackson et al. 2018). The report documents a cultural resources survey encompassing 1.8 acres. No new archaeological resources were identified during the course of the survey. Four structures dating to 50 years or older were identified, but not documented using the Ohio Historic Inventory forms. They were recommended as not eligible for listing on the National Register of Historic Places.

Based on the information submitted, it is our opinion that no properties listed or eligible for listing on the National Register of Historic Places will be affected by the proposed undertaking. No further coordination is necessary unless the project changes or archaeological remains are discovered during the course of the project. In such a situation, this office should be contacted as per 36 CFR 800.13. Thank you for your cooperation. Please be advised that this is a Section 106 decision. This review decision may not extend to other SHPO programs.
