## COMMENTS OF AARP November 27, 2018

AARP is the nation's largest nonprofit, nonpartisan organization dedicated to empowering Americans 50 and older to choose how they live as they age. AARP's Ohio membership includes 1,509,733 adults. AARP seeks to guarantee that all residents in Ohio have access to affordable and fair utility rates and reliable electric service.

Older adults are especially vulnerable to high utility prices, in part, because they often spend a large proportion of their income on home-energy costs. Data shows that Ohio has 2,290,813 Social Security beneficiaries and 52.3% of those beneficiaries rely on Social Security for 50% or more of their income. The number of beneficiaries relying on Social Security for 90% or more of their income is a sobering 23%. The average Social Security benefit for a 65+ family is only about \$18,000 per year, while older Ohio families on average spend \$19,000 a year on food, utilities, and health care alone. Studies also show older people limit or do without food, medical services and prescription medicine to pay for higher energy bills. Simply put, older Ohioans simply cannot afford the increases requested by Vectren Energy Delivery of Ohio, Inc., especiallyh.

Our specific comments are as follows:

## 1. The customer charge should not be increased.

Vectren proposes going from \$18 per month to \$35 per month for its customer charge. AARP strongly opposes such a change. The current charge is already too high and the proposed 94.4% increase is questionably egregious. Higher customer charges make it harder for consumers to control their own energy bill and the proposed rate increase means that consumers would be hit with a monthly charge of approximately \$50 before even consuming any natural gas. Higher customer charges also have been shown to discourage consumption conservation by lowering the per therm volumetric rate through.

Customer charges should collect metering and billing costs <u>only</u> as they have traditionally. AARP opposes the move by utilities to try and move more revenue collection via the customer charge (aka straight fixed variable rate design).

The PUCO should reject any increase to the already too high charge of \$18 per month, especially with no guaranteed visibility to how these additional charges would be reinvested or applied to benefit the consumer.

## 2. AARP opposes the proposed new rider.

AARP also objects to Vectren's request to institute a new capital expenditure program rider via an alternative regulatory plan. Instead of filing a traditional rate case where all expenditures and offsetting savings could be scrutinized, an approval of Vectren's request would change rates annually via a new surcharge which it claims would add \$1.35 per month or more to customer bills.

AARP just helped defeat similar proposals in North Carolina and North Dakota where regulators noted that no new regulatory mechanism was needed and the proposal lacked sufficient detail. The PUCO should similarly reject this proposal.

AARP objects to such single issue ratemaking, which fast tracks spending recovery and ignores offsetting cost reductions (and limits regulatory review). There is simply no need to bypass traditional review no matter how much worthy the spending.

In summary, the PUCO should not allow Vectren to increase its monthly customer charge which is already too high. It should also reject the capital expenditure program rider. Our members —many of whom are on low or fixed incomes — cannot afford to pay \$50 per month in fees before even turning on their gas, simply to be a Vectren customer.
