PAULDING WIND FARM IV LLC'S LIST OF ISSUES

On July 2, 2018, as supplemented on July 27, 2018, August 14, 2018, and October 24, 2018, Paulding Wind Farm IV LLC ("Applicant") filed an application with the Ohio Power Siting Board ("OPSB") proposing to construct a wind-powered electric generation facility in Paulding County, Ohio.

By entry issued September 18, 2018, the OPSB established the procedural schedule in this matter and directed that the OPSB staff issue its report of investigation ("Staff Report") by November 19, 2018, and that parties file their list of issues about which they may be interested in pursuing cross-examination of witnesses at the December 14, 2018 hearing. Upon review of the Staff Report, the Applicant notes that it may be interested in discussion and clarification regarding Staff Report Conditions 20, 21, 23(a), and 26.

The Applicant, by providing this list, is not waiving its right to address other issues and reserves its right to include additional issues upon cross-examination.
