1	1.	Q.	Please state your name and your business address.
2		A.	My name is Jon C. Pawley, and my business address is 180 East Broad
3			Street, Columbus OH 43215.
4			
5	2.	Q.	By whom are you employed and what is your position?
6		A.	I am employed by the Public Utilities Commission of Ohio (Commission)
7			as a Utility Specialist 3 in the Siting, Efficiency and Renewable Energy
8			Division of the Commission's Rates and Analysis Department.
9			
10	3.	Q.	Please summarize your educational background and work experience.
11		A.	I received an Associate of Applied Science degree in Architectural
12			Technology from SUNY Alfred State College in 1986, a Bachelor of Arts
13			degree in Environmental Design from the University of Buffalo in 1991,
14			and a Master of City and Regional Planning degree from The Ohio State
15			University in 1993.
16			
17			I have been employed by the Commission for roughly twenty years. More
18			recently, my responsibilities at the Commission have primarily involved
19			social and cultural resource matters associated with site planning of major
20			utility facilities in the state of Ohio. I have also been the Staff lead on
21			numerous applications for a Certificate of Environmental Compatibility and

1			Public Need before the Board. Additionally, I have over ten years
2			experience in public and private sector development and planning.

4	4.	Q.	Have you testified in prior proceedings before the Board?
5		A.	Yes. I have testified in many cases before the Board concerning Staff's
6			investigation and report findings and recommendations on proposed siting
7			projects involving power plants, wind farms, substations, and transmission
8			lines.

10	5.	Q.	What is the purpose of your testimony in this proceeding?
11		A.	I am sponsoring the Staff Report of Investigation (Staff Report) that was
12			filed November 14, 2018 in this docket. I am the Staff project lead. I man-
13			aged the Staff investigation and preparation of the Staff Report in this case.
14			I am also supporting the Joint Stipulation on behalf of Staff, filed in this
15			case on December 4, 2018.
16			
17	6.	Q.	Please describe the type of case being considered in this proceeding.
18		A.	The Applicant proposes to build a new 138 kV transmission line between
19			the Glencoe Station (under construction – reference Case Nos. 16-1609-EL-
20			BLN and 17-1211-EL-BNR) and existing Speidel Station that would
21			operate at 69 kV until 138 kV standards would be needed to serve future
22			customer load.

1	7.	Q.	Please summarize Staff's investigation that was conducted in this case.
2		A.	Staff's investigation included reviewing the application, conducting site
3			visits to the proposed facility location, acquiring additional information
4			from the applicant, obtaining input from state agencies that comprise the
5			Board along with other relevant state and federal agencies, and preparing a
6			Staff Report that presents Staff's analysis, conclusions, and
7			recommendations. As a result of Staff's investigation, Staff is recom-
8			mending that the Board approve the application, subject to the 19 condi-
9			tions that are presented in the Stipulation.
10			
11	8.	Q.	Does this conclude your testimony?
12		A.	Yes, it does. However, I reserve the right to submit supplemental testi-
13			mony, as new information subsequently becomes available or in response
14			to positions taken by other parties.
