{¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon Steven J. Dodson (Respondent) alleging violations of the Commission's transportation regulations.

{¶ 2} On August 6, 2018, counsel for Respondent filed a request for an administrative hearing regarding the NPD as contemplated by Ohio Adm.Code 4901:2-7-13. On September 5, 2018, counsel filed a notice of withdrawal and requested that all further communications be directed to Respondent.

{¶ 3} Meanwhile, on August 29, 2018, another attorney filed a second request for an administrative hearing regarding the same NPD, or at least regarding the same Ohio Motor Carrier Information System (OMCIS) Report No.: OH1359002536D. This second request for an administrative hearing was assigned Case No. 18-1347-TR-CVF.

{¶ 4} By Entry dated October 29, 2018, the attorney examiner directed the parties to participate in a prehearing conference on December 18, 2018. Due to a scheduling conflict, the attorney examiner continues the prehearing conference to Thursday, January 31, 2019, at 11:00 a.m. At that time, and because Respondent is represented by an attorney in Case No. 18-1347-TR-CVF, the attorney examiner will attempt to contact Respondent's counsel, Mr. Michael J. Yemc, Jr., by telephone at his office number: 614-228-2699.
