Enclosed are Ohio Power Company's (AEP Ohio's) compliance tariffs, which are being filed in accordance with the Commission's Opinion and Order dated December 19, 2018 in Case No. 18-976-EL-USF. Starting 2019, CSP and OP rate zone is combined into one. The Commission ordered AEP Ohio to apply the undistributed FAC Refund balance (\$16,123,501) and the SEET Refund balance (\$375,651), totaling \$16,499,152, to the USF Revenue requirement. Accordingly, the proposed USF rate reflects application of a credit of \$1,374,929.33 per month for twelve months.

The Company will update its tariffs previously filed electronically with the Commission's Docketing Division.
