1.0 INTRODUCTION

1.1 Purpose and Goals of the Investigation

Republic Wind, LLC (hereafter referred to as the Applicant) is proposing to construct the Republic Wind Project (hereafter referred to as the Project) in Adams, Pleasant, Reed, Scipio, and Thompson Townships, Seneca County and York Township, Sandusky County. The Applicant is currently in the process of amending their Application for a Certificate of Environmental Compatibility and Public Need (the Application), in compliance with Section 4906.06 of the Ohio Revised Code and in accordance with Chapters 4906-4-01 through 4906-4-08 of the Ohio Administrative Code (OAC), as effective February 2018, when the original Application was submitted.

On behalf of the Applicant, EDR prepared the following cultural resources records review in support of environmental review and permitting for the proposed Project. This cultural resources records review has been prepared by a Registered Professional Archaeologist (RPA) who meets the Secretary of the Interior's Standards for Archaeology (36 C.F.R. Part 61) and a qualified architectural historian who meets the U.S. Secretary of Interior's Standards for Historic Preservation (36 C.F.R. Part 61). The cultural resources records review and impact assessment is designed to satisfy the requirements of the Ohio Administrative Code Chapter 4906-04-08(D)(1) and (2) for the OPSB which requires that all cultural resources be evaluated within five miles of the Project Area¹.

1.2 Project Location and Description

The Project Area is defined as the area encompassing all Project-related development and consists of approximately 24,000 acres of private land in Adams, Pleasant, Reed, Scipio, and Thompson Townships (Seneca County) and York Township (Sandusky County). The Project presented herein consists of up to 50 wind turbine generators, each with a nameplate capacity rating of 4.2 to 4.5 megawatts (MW), depending on the final turbine model selected. In addition to the turbines, the Project will include up to approximately 20 miles (32 kilometers [km]) of access roads, up to approximately 83 miles (133 km) of buried 34.5 kV electrical collection cable, a collection substation, a temporary laydown yard for construction staging, an O&M building, and up to three permanent meteorological towers. A detailed description of the Project, including each Project component, can be found in Section 4906-4-03(B) of the Application.

The following terms are used throughout this document to describe the proposed action:

¹ Because this case is subject to earlier OPSB rules under Chapter 4906 of the Ohio Revised Code and Chapters 4906 of the OAC, identification of historic landmarks is only required within five miles of the proposed project rather than 10 miles as required under current regulation.

<u>Project:</u>	Collectively refers to all components of the Republic Wind Project, which is permitting up to 50 wind turbines and associated infrastructure in Seneca and Sandusky Counties, Ohio.
<u>Project Area:</u>	Those parcels currently under, or being pursued, for lease (or other real property interests) with the Applicant for the location of all Project components (which will be defined in the Certificate Application).
<u>Study Area:</u>	The area within five miles of the Project, which is defined in Section 1.3 of this report as the appropriate study area for indirect (visual) effects on cultural resources.
<u>APE for Direct Effects:</u>	The area of potential effect (APE) for Direct Effects for the Project is the area containing all proposed soil disturbance associated with the Project.
<u>APE for Indirect Effects:</u>	The APE for Indirect Effects on historic resources includes those areas where the Project may result in indirect effects on cultural resources, such as visual impacts. As presently envisioned, the APE for Indirect (Visual) Effects for the Project is the area within five miles of proposed turbines (the Study Area) which are within the potential viewshed (based on topography) of the Project.

1.3 Area of Potential Effect

The Area of Potential Effect (APE) for Direct Effects to historic resources is defined as all areas where potential soil disturbance (or other direct, physical impacts) is anticipated during construction of the Project. Preliminary design of the Project is underway, but the final layout will occupy less than the Project Area (see Figure 2). Therefore, the total ground disturbance during construction is anticipated to be minimal relative to the overall size of the Project Area.

The APE for Indirect Effects on historic resources includes those areas where the Project may result in indirect effects on cultural resources, such as visual or auditory impacts. The Project's potential indirect effect on historic resources would be a change in the historic resource's setting resulting from the introduction of wind turbines or other project components. This could theoretically consist of auditory and/or visual impacts; however, utility-scale wind facilities produce minimal noise, so auditory impacts resulting from the Project are not considered a significant type of impact to the setting of historic resources. Therefore, potential visual impacts associated with the Project are the most significant consideration for defining an APE for Indirect Effects.

Additional information about indirect effects is found below in Section 2.3. Impact Assessment

2.0 RECORDS REVIEW AND IMPACT ASSESSMENT

2.1 Methodology

Per the requirements of Ohio Administrative Code Chapter 4906-04-08(D), the cultural resources records review was completed for the area within a 5-mile radius of the Project (“the Study Area”, see Figure 2) and included the following records available from the Ohio State Historic Preservation Office (OHPO):

- National Register of Historic Places (NRHP)
- NRHP Determination of Eligibility (DOE)
- National Historic Landmarks (NHL)
- Ohio Historic Inventory (OHI)
- Ohio Department of Transportation (ODOT) Historic Bridge Inventory
- Ohio Archaeological Inventory (OAI)
- Ohio Genealogical Society (OGS) cemetery files
- Mills *Archaeological Atlas of Ohio* (1914)
- OHPO previous cultural resources surveys

2.2 Cultural Resources Records Review

Archives and repositories consulted during EDR’s research for the project included the online Geographic Information Systems (GIS) mapping system of the OHPO (Ohio History Connection, 2018), the David Rumsey map collection (Cartography Associates, 2018), and EDR’s in-house collection of reference materials. The results of the cultural resources records review for the Study Area associated with the Project are described below and depicted on Figures 3 and 4.

2.2.1 National Register of Historic Places (NRHP)

The records review of the OHPO online GIS mapping system identified 10 NRHP-listed properties recorded within the Study Area. Two of these properties are located within the Study Area (see Figure 3 and Appendix A).

- Heter Farm (79NR001941) is a grouping of agricultural buildings consisting of a Greek Revival farm house, a bank barn of mortise-and-tenon construction, and smaller support buildings, all constructed circa 1850.
- Henny Barn (79NR003646) is a wood frame barn using the principles of a particular frame construction method patented by Rev. William Morris and Joseph Slanser of Marion County, Ohio in 1877. Only one other barn in the Seneca County is known to have been constructed using this method. The goal of the patent was to provide “an improved method of erecting frame buildings by the use of planks of suitable length and

thickness, from which the posts, beams, joists are formed so that any person may be enabled to put up such with great facility, a saving of timber, and without requiring skilled help" (Drown, 1978).

2.2.2 NRHP Determination of Eligibility (DOE)

The records review of the OHPO online GIS mapping system identified four NRHP-eligible historic properties that are located within the Study Area, none of which are located within the Project Area (see Figure 3 and Table 1).

2.2.3 National Historic Landmarks (NHL)

No designated National Historic Landmarks are located within the Study Area.

2.2.4 Ohio Historic Inventory (OHI)

The records review of the OHPO online GIS mapping system identified 387 OHI properties recorded within the Study Area, 44 of which are located within the Project Area (see Figure 3 and Appendix B).

2.2.5 Historic Bridge Inventory (ODOT)

The ODOT Historic Bridge Inventory lists two historic bridges that are NRHP-eligible within the Study Area, none of which are located within the Project Area (see Figure 3 and Table 2).

- ODOT Bridge Number 7450192 is the Township Road 80 bridge over Royer Ditch in Thompson Township, Seneca County, which is a reinforced concrete slab type bridge.
- ODOT Bridge Number 74001618 is the Mull Road Covered Bridge over the East Branch Wolf Creek in Sandusky County. It is a wood lattice through truss-type bridge, constructed in 1851.

2.2.6 Ohio Archaeological Inventory (OAI)

The records review of the OHPO online GIS mapping identified 666 OAI properties have been recorded within the Study Area, 79 of which are located within the Project Area (see Figure 3 and Appendix C).

2.2.7 Ohio Genealogical Society (OGS)

The records review of the OHPO online GIS mapping identified 63 OGS cemeteries have been recorded within the Study Area, five of which are located within the Project Area (see Figure 3 and Appendix D).


2.2.8 Mills Archaeological Atlas of Ohio (1914)

A review of the 1914 *Archaeological Atlas of Ohio*, Mills (1914) indicates the following for the four counties contained within the Study Area:

- **Erie County:** According to Mills (1914), the primary pre-contact habitation in Erie County focused along the lakeshore of Erie County. The Study Area only occupies the very southwestern corner of Erie County and the Project Area is not located in Erie County. Mills (1914:22) does not depict any archaeological sites within the Study Area.
- **Huron County:** According to Mills (1914), the most significant pre-contact earthworks in Huron County occur near the City of Norwalk, well outside the Study Area. Mills (1914:39) does not depict any archaeological sites within the Study Area, and the Project Area is not located in Huron County.
- **Sandusky County:** According to Mills (1914), Sandusky County was significant during the pre-contact period because several major trails came together near the south shore of Sandusky Bay. However, Mills (1914:72) also notes there were: “a number of enclosures and other works found along the Sandusky river”. One enclosure was located where the City of Fremont now stands, while between that City and the bay there were at least five others. One was located immediately south of Fremont and another near the south line of the county...” Mills (1914:72) depicts three archaeological sites (one burial, one enclosure, and one mound) within the Study Area; however, none of the sites are within the Project Area itself.
- **Seneca County:** Mills (1914:74) notes a moderate density of pre-contact archaeological sites within Seneca County, including a dense area of prehistoric habitation in Thompson Township in the northeastern corner of the county (partially within the Project Area). Additionally, the “old Scioto Trail” followed the Sandusky River

through the central portion of the county (within the western edge of the Study Area) to its termination at Sandusky Bay to the north. According to Mills (1974:74), nine archaeological sites occur within the Study Area: five village sites, three burial sites, and one cemetery. Two of the village sites occur within the Project Area. The villages are depicted in the vicinity of proposed Project components and may be located within the Project footprint.

In summary, Mills (1914) depicts a total of 12 pre-contact archaeological sites within the 5-mile Study Area (three in Sandusky County and nine in Seneca County), which include two archaeological sites (both villages) within the Project Area (see Inset 1). The two village sites depicted within the Project Area may occur within the current Project footprint; however, the Mills (1914) maps are not sufficiently detailed to identify the precise locations of the resources depicted. It is notable that significantly more archaeological sites described by Mills (1914) occur within the Study Area than within the Project Area. This is in part due to the large size of the Study Area; however, the paucity of previously recorded pre-contact archaeological sites also may be attributable to the lack of major rivers within the Project Area. The Project is located on a relatively level plain between the Sandusky River to the west and the Huron River to the east and contains only a few small creeks within its boundaries.

2.2.9 Previous Cultural Resources Surveys

2.2.9.1 Archaeological Surveys

Per the OHPO GIS mapping system, 42 Phase I archaeological surveys and four Phase II archaeological investigations have been completed within the Study Area, one of which is located within the Project Area (Figure 4, Appendix E). The Phase I archaeological surveys were completed for 11 communications towers, eight municipal development projects, six industrial development projects, four residential developments, three water pipelines, three gas pipelines, two bridge replacements, two transportation/roads projects, two railroad projects, and one transmission line. Two of the Phase II investigations were completed at pre-contact sites and two were completed at multi-component pre-contact and historic-period sites.

2.2.9.2 Historic Architectural Surveys

One historic architectural resources survey (Figure 4), has been completed within the Study Area, and is summarized below. Additionally, a cultural resources records review and a historic architectural resources windshield survey were completed, but never submitted to OHPO, for a previous iteration of the Republic Wind Project. All three previous studies are discussed below.

In 2002, a historic resources survey was completed by the Mannik & Smith Group (MSG) within a 0.5-mile buffer around the proposed Bellevue Grade Separation Site (OHPO Survey ID H00220), located northeast of the Project Area, but within the Study Area, in Bellevue, Ohio (MSG, 2002). No NRHP-listed properties were identified within the Bellevue Grade Separation Study Area. However, forty-nine previously recorded OHI sites (pre-1952) were identified within the Bellevue Grade Separation Study Area, with one located in the Bellevue Grade Separation Project Area. Through a reconnaissance survey completed in November and December of 2001, an additional 25 resources older than 50 years were identified. Of those 25 resources, three retained a high degree of integrity and were listed in the OHI (MSG, 2002).

In 2012, the Hardlines Design Company of Columbus (HDC), on behalf of BHE Environmental, Inc. (BHE) of Cincinnati, completed a cultural resources records review for an earlier version of the Republic Wind Project which involved 60-80 turbines over 47 square miles (HDC, 2012). This layout had similar, but not identical, Project and 5-mile Study Area boundaries to the currently proposed Project and identified 363 previously surveyed buildings with OHPO resource forms, 30 within the footprint of the Project. Using HDC's report as a foundation, BHE subsequently completed a Phase IA 5-mile architectural windshield survey, identifying nine NRHP-eligible or -listed properties (BHE, 2012). Neither the HDC, nor the BHE reports, were submitted to OHPO.

There were two discrepancies between the 2002 MSG study and the 2012 BHE study when compared to current data on the OHPO GIS website. Per the MSG report (2002), the property at 210 Kilbourne Street in Bellevue was previously recorded as SAN0000512. However, it is now known as resource SAN0037912, which has been updated in Appendix D. In the BHE report (2012), the William Baker House (resource SEN0099805) was indicated as listed on, or eligible for, the NRHP. The OHPO GIS database indicated that it had not been listed, nor evaluated. Communication with OHPO clarified that formal evaluation of that property had not taken place.²


2.2.10 Historic Map Review

Historic maps reviewed included the 1872 Gray and Walling *Topographical Atlas of Cuyahoga, Erie, Huron, Lorain, Medina, Ottawa, Sandusky, Seneca, and Summit Counties, Ohio* (Figure 5), the USGS 1901 *Elmore, Fostoria, OH*,

1903 *Bellevue, Fremont, OH*; 1904 *Sandusky, OH*; 1906 *Sycamore, Tiffin, OH*; and 1915 *Bucyrus, Crestline, Norwalk, Siam, OH* 1:62500 Topographical Quadrangles (Figure 6), the 1914 Mills Archaeological Atlas of Ohio (Inset 1), and the USGS 1950 *Marion, OH* and 1956 *Toledo, OH* 1:250000 Topographical Quadrangles (Figure 7).

An excerpt from the 1872 Gray and Walling Topographical *Atlas of Cuyahoga, Erie, Huron, Lorain, Medina, Ottawa, Sandusky, Seneca, and Summit Counties, Ohio* (Figure 5) depicts the Project Area within Adams, Pleasant, Reed, Scipio, and Thompson Townships in Seneca County, York Townships in Sandusky County. Lots are separated into 1-mile grids, with orthogonal roadways along most of those boundaries. Diagonal thoroughfares, including the Cleveland, Columbus, Cincinnati and Indianapolis Railway (opened 1868) cross through the grid at the western side of the Project Area. The diagonal coach road that bisects the Project Area leads into Bellevue, featured on the 1888 Burleigh and Norris *Birdseye View of Bellevue, Ohio* (Burleigh Lithograph Co, 1888; Inset 2). Though generally the Atlas does not depict structures, a handful of buildings in the villages of West Lodi, Flat Rock, Watsons Station and Adams (present-day Lowell) were drawn, suggesting that by 1872 they were burgeoning settlements in an agricultural landscape.

The 1880s brought the railroad into northern Ohio, adding several thousand people to the population of Bellevue in southeast Sandusky County, transforming it from a rural village into a small town. (Burleigh Lithograph Co, 1888; Library of Congress website)

The USGS 1901 *Elmore, Fostoria, OH*; 1903 *Bellevue, Fremont, OH*; 1904 *Sandusky, OH*; 1906 *Sycamore, Tiffin, OH*; and 1915 *Bucyrus, Crestline, Norwalk, Siam, OH* 1:62500 Topographical Quadrangles (Figure 6) are largely similar to

the 1872 Gray and Walling Atlas with the addition of map-documented structures, including schools. A new rail line, the Norfolk and Western (opened in 1881), appears at the east side of the Project Area, passing through Flat Rock and connecting to Bellevue. The highest density of buildings is in Flat Rock and West Lodi putting them ahead of Adams in terms of population growth.

The 1914 Mills *Archaeological Atlas of Ohio* (Inset 1) was also reviewed during background research for the Project Area, and prehistoric archaeological sites depicted in the atlas were discussed in Section 2.2.9 of this report. In addition to archaeological sites, the Mills Atlas also depicts the state of development throughout Ohio in 1914. Relative to the earlier maps of Seneca and Sandusky Counties, the Mills (1914) maps show a similar pattern of development in the Study Area, albeit at a decreased level of detail, with the landscape divided into 1-mile sections and major roads radiating out from population centers. West Lodi and Flat Rock continued to serve in their roles as commercial centers in northeast Seneca County. Roads in the 1914 Mills atlas are approximately in their modern alignment.

The USGS 1950 *Marion, OH* and 1956 *Toledo, OH* 1:250000 Topographical Quadrangles (Figure 7) show similar conditions to the 1914 Mills Atlas, with the appearance of a new hamlet, Cooper, at the intersection of County Routes 101 and 18 in the center of the Project Area. By the 1950s modern naming conventions have replaced historic ones; Lowell and Adams are now known only as Lowell, and many streets have been given county route numbers. Rural development remains sparse and spaced out along county and local roads, concentrated at their intersections. The mid-twentieth century USGS maps depict similar patterns of the development to the present day.

2.3 Impact Assessment

Per the requirements of 4906-4-08(D) of the Ohio Administrative Code, EDR assessed the potential impact(s) on cultural resources that could result from construction and operation of the Project. The results of this impact assessment are discussed below.

2.3.1 Potential Direct Effects

Based on current design, there will be no direct impacts to known cultural resources (i.e., cemeteries or historic structures) from construction of the Project. The Applicant will seek to avoid any potentially significant (i.e., NRHP-eligible or -unevaluated) archaeological sites located within the Project Area.

2.3.2 Potential Indirect Effects

The Project has the potential to cause indirect (visual) impacts to aboveground historic resources within the Cultural Resource Study Area. A complete Visual Resources Assessment will be prepared in support of the Certificate Application for the Project, in accordance with Ohio Administrative Code Chapter 4906-04-08(D)(4). The Visual

Assessment includes viewshed analyses and photographic simulations and assesses the potential visual impacts of the Project.

3.0 SUMMARY AND CONCLUSIONS

3.1 Summary of Cultural Resources Records Review

EDR prepared this cultural resources records review in support of environmental review and permitting for the proposed Republic Wind Project. This report is designed to satisfy the requirements of Ohio Administrative Code Chapter 4906-04-08(D)(1) and (2) for the OPSB. The results of the Cultural Resources Records Review for the proposed Republic Wind Project can be summarized as follows:

- 10 NRHP-listed resources have been recorded within the Study Area. Five NRHP-listed properties are located within the Project Area (see Appendix A).
- 4 resources previously determined eligible to the NRHP have been recorded within the Study Area. No NRHP-eligible properties are located within the Project Area.
- No NHLs have been recorded within the Study Area.
- 387 OHI properties have been recorded within the Study Area. Forty-four OHI properties are located within the Project Area (see Appendix B).
- Two historic bridges within the ODOT inventory have been recorded within the Study Area. No ODOT historic bridges are located within the Project Area.
- 666 OAI properties have been recorded within the Study Area. Seventy-nine are located within the Project Area (see Appendix C).
- 63 OGS cemeteries have been recorded within the Study Area. Five OGS cemeteries are located within Project Area (see Appendix D).
- Forty-two Phase 1 archaeological surveys and four Phase 2 archaeological investigations have been completed within the Study Area. One of the Phase 1 surveys is located within the Project Area (see Appendix E).
- The 1914 Mills *Archaeological Atlas of Ohio* depicts a total of 12 pre-contact archaeological sites within the Study Area (three in Sandusky County and nine in Seneca County), which include two archaeological sites (both villages) within the Project Area.






Figure 3: Previously Identified Cultural Resources


Figure 3: Previously Identified Cultural Resources - Sheets


Figure 3: Previously Identified Cultural Resources - Sheets


Figure 3: Previously Identified Cultural Resources - Sheets










