**JOINT MOTION FOR CONTINUANCE
AND REQUEST FOR EXPEDITED CONSIDERATION**

Vectren Energy Delivery of Ohio, Inc. (VEDO or the Company) and the Staff of the Public Utilities Commission of Ohio (Staff), jointly “Movants,” respectfully request that the date for the evidentiary hearing in this matter be continued. Hearing is presently scheduled to begin January 7, 2019. Movants request that the hearing be continued first to 2:00 p.m. on January 7, 2019, and again thereafter at least three (3) weeks, or to begin no earlier than January 28, 2019.

Movants make this request pursuant to O.A.C. 4901-1-13(A) due to the filing of a written stipulation this date. Movants recognize that additional time is necessary to afford non-signatory parties an opportunity to prepare for hearing on the filed stipulation.

Pursuant to Ohio Admin. Code 4901-1-12(C), Movants further request an expedited ruling on this motion. Inasmuch as Movants anticipate that the hearing will be called to order on January 7, 2019, intervening parties will have ample opportunity to respond to this motion at that time.
