MEMORANDUM IN SUPPORT

On December 6, 2018, the Attorney Examiner issued an entry establishing a procedural schedule in the above referenced matters. Specifically, the Attorney Examiner set forth the following schedule:

- IGS testimony: January 28, 2019
- Hearing resumes (for one witness): February 1, 2019
- Discovery cut-off (for paper discovery other than notices of depositions): February 4, 2019
- Hearing resumes: February 26, 2019

IGS then served discovery upon DP&L. Subsequently, to accommodate holiday schedules, DP&L requested and received two extensions to respond IGS' discovery. Due to these delays, IGS moves to modify the procedural schedule. To ensure that IGS may properly prepare for trial, IGS proposes to extend the deadline for discovery and
