Duke Energy Ohio, Inc., (Duke Energy Ohio) is filing this Pre-Application Notification Letter in accordance with O.A.C. 4906-6-03(A).

Duke Energy Ohio is planning to modify three existing 138-kilovolt (kV) transmission lines. Modifications will include replacing an existing lattice tower and 6 wood poles with steel poles and installing 11 new steel poles to route the three transmission lines into the proposed 138-kV substation yard at Garver Substation. The poles have a height of 60-to-115 feet above ground. This work will occur to the east and south of the existing Garver Substation in Middletown within Butler County, Ohio.

Construction is planned to begin March 4, 2019, upon approval of this Letter of Notification. The Project is anticipated to be completed and in-service by November 8, 2019.

Pursuant to O.A.C. 4906-6-04, Duke Energy Ohio is requesting an expedited review.
