**MEMORANDUM IN SUPPORT** 

Recall that this case involves construction projects at four separate grade crossings in

Dayton, Montgomery County: Irwin Street (DOT #527818F), Miami Chapel Road (DOT #524629Y),

Findlay Street (DOT #527819M), and Stewart Street (DOT #524628S).

Irwin was placed in-service as of November 5, 2018, and weather permitting, Miami

Chapel is now expected to be placed in-service by February 11, 2019 (the current deadline, as

extended).

But ongoing utility concerns have delayed final construction and cut-in at the two

remaining crossings – specifically, Findlay and Stewart.

At Findlay, substantial progress has been made, as all railroad equipment is in the

ground and ready to be placed in-service, once the sole remaining overhead utility conflict (Crown

Castle) is resolved – specifically, on the north side of the tracks, Crown Castle remains in the process of

raising its line approximately two feet, to provide adequate clearance. Once the Crown Castle utility

conflict is resolved, then weather-permitting, NSRC expects to be able to place this crossing in-service,

within approximately thirty (30) days.

Stewart is more problematic, in that there are multiple remaining overhead utility

conflicts (Dayton Power & Light, Spectrum/Charter, and Lighthouse/Crown Castle) involving shared

poles. NSRC is working with the involved utilities, toward resolving these conflicts – specifically, to

NSRC's current understanding, both Spectrum/Charter and Lighthouse/Crown Caste intend to transfer

their utilities to new poles. Once the requisite logistics are resolved, Spectrum/Charter advises that it

will need a three (3) week or so buffer, to give its customers notification of a possible outage while its

does its work; and then once all utility concerns are resolved, NSRC anticipates that it will need an

additional seven (7) weeks or thereabouts, within which to place the railroad equipment into the

ground, and to place this crossing in-service.

For the foregoing reasons, NSRC respectfully requests that the Commission grant it a

further extension of time here, through July 11, 2019, within which to complete construction at Findlay

and Stewart.
