MEMORANDUM IN SUPPORT

On July 16, 2018, as amended on July 20, 2018, and as modified thereafter, Seneca Wind, LLC (“Seneca Wind”) filed its application for a certificate of environmental compatibility and public need for a wind-powered generating facility in Seneca County, Ohio (“Application”). On December 7, 2018, the Ohio Power Siting Board (“OPSB” or “Board”), through its administrative law judge (“ALJ”), issued an entry establishing a procedural schedule for this case.

Pursuant to OAC 4906-2-07(A) and OAC 4906-2-27(A), Seneca Wind and the Board Staff move the Board for a modification of the current procedural schedule. Seneca Wind and Staff request that the Board toll the dates set forth in the procedural schedule, and establish a new procedural schedule as follows:

1. April 1, 2019 – Filing of the Staff Report
2. April 8, 2019 – Filing of issues lists
3. April 18, 2019 – Seneca Wind shall file its testimony
4. The week of April 22 – The local public hearing
5. April 25, 2019 – Staff and intervenors shall file testimony
6. April 26, 2019 – Filing of any stipulation of the parties
7. No sooner than April 30, 2019 – Adjudicatory hearing

Tolling of the current procedural schedule will provide Seneca Wind sufficient time to provide Staff additional information that it needs to complete its investigation. In addition, this modification of the procedural schedule will not negatively impact any parties to this proceeding. The movants are not seeking to stay discovery during this tolling period. Accordingly, Seneca Wind and Staff request that the ALJ or Board modify the procedural schedule.
