- {¶ 2} On April 16, 2018, as amended and supplemented on May 31, 2018, June 26, 2018, and September 19, 2018, AEP Ohio filed its long-term forecast report (LTFR) for 2018 in Case No. 18-501-EL-FOR (*LTFR Case*).
- {¶ 3} By Entry dated October 22, 2018, the *LTFR Case* was consolidated with Case No. 18-1392-EL-RDR and Case No. 18-1393-EL-ATA and the proceedings were bifurcated into two phases.
- {¶ 4} The evidentiary hearing for the first phase of these proceedings was called, as scheduled, on December 4, 2018, continued to January 15, 2019, and concluded on February 8, 2019. At the conclusion of the hearing, the parties agreed to file initial briefs by March 6, 2019, and to file reply briefs by March 27, 2019.
