Industrial wind farms do not have any business in residential areas. We fought for our rural beauty here on the South side of Van Wert County and for now, have pushed the Big Wind Company out of our area. We will remain diligent in keeping them out. We will stand for other counties all across the United States to keep industrial wind turbines from ruining their dreams, health, peacefullness, and safety.
