We are here 7 this morning for Case No. 16-122-TR-ORD regarding 8 adoption of rules related to the regulation of 9 transportation network companies. 10 The 131st General Assembly adopted SB 237 11 to, in part, amend Revised Code 4925.01 through 12 4925.10. Newly adopted RC 4925.02 authorizes the 13 Commission to adopt rules under RC Chapter 119 for 14 purposes of issuing permits to transportation network 15 companies. 16 On February 21, 2018, a year ago today, 17 the Commission issued a finding and order that 18 proposed Ohio Administrative Code Chapter 4901:2-23 19 be adopted. Those proposed rules were recently filed 20 with the Joint Committee on the Agency Rule Review. 21 And pursuant to RC 119 we are here today 22 to entertain any further comments. So at this point 23 we will take comments from any interested parties. 24 We have a court reporter who will file the transcript of this hearing in the docket and a summary of 25
