### PROJECT DESCRIPTION

As previously indicated, Vectren Energy Delivery of Ohio ("VEDO") will retrofit an existing pipeline to allow inspection by modern in-line inspection tools (ILITs). The Project will replace approximately 8,500 feet of 16" natural gas pipeline with 20" pipeline. The Project corridor extends from the existing Memorial Station on WPAFB to Wrightway Road, along the north side of State Route 4. The existing regulator station would be rebuilt as well. The Project would also include the construction of an ILIT launcher/receiver located on the north side of State Route 4. Wright Station #1, located on WPAFB, would also be retired.

### **CONSTRUCTION SCHEDULE**

VEDO anticipates construction of the pipeline to begin on or around March 11, 2019. Construction is expected to last through December 2019.

#### **RESTORATION**

After completion of construction, VEDO will restore the affected property to its pre-construction condition as soon as weather allows. VEDO expects that all restoration activities will be completed by December 2019.


