 Re: PUCO Case No. 17-628-RR-FED - In the Matter of a Consolidation Project for Crossings in the Village of Bellmore in Putnam County, Ohio.

On October 31, 2016, the Ohio Rail Development Commission (ORDC) authorized construction for CSX Transportation to install lights and gates at three crossings and the closure of one crossing in the Village of Bellmore at the following locations:

Street	DOT#	County	Project
Oak Street	155-744L	Putnam County	Lights and Gates
Main Street	155-745T	Putnam County	Lights and Gates
Elm Street	155-746A	Putnam County	Closure
Ridge Street	155-747G	Putnam County	Lights and Gates

On April 12, 2017, the Commission approved the project and ordered completion by April 12, 2018.

On March 16, 2018, CSX filed for a six month extension to the project deadline. In the request, CSX stated that due to limited crew availability while the federally mandated positive train control initiative is being completed, the work regarding the crossings is being delayed. The Commission granted a 30 day extension. On April 27, 2018, CSX filed an extension request until June 12, 2018. The Commission granted the extension request on May 9, 2018.

The crossing projects have been completed and are in-service as follows (see attached):
