Dear Administrative Law Judge Jones:

On January 31, 2019, as supplemented on March 18, 2019, Firelands Wind, LLC ("Applicant") filed an application with the Ohio Power Siting Board ("Board") for a Certificate of Environmental Compatibility and Public Need to Construct a Wind-Powered Electric Generation Facility in Huron and Erie Counties, Ohio.

On March 29, 2019, the Board's Staff ("Staff") filed a letter requesting that the Board waive application of the timing requirement in Ohio Administrative Code Rule 4906-3-06(A), until April 17, 2019. Staff submits that this additional time will give the Applicant the ability to supplement the application with a summary of the comments received at the April 3, 2019 public information meeting and give Staff the opportunity to recommend the application be found either complete or incomplete.

The Applicant supports an extension of time to allow for the filing of the summary from the April 3, 2019 meeting and for Staff's review. It is the Applicant's intent to file the summary as soon as possible following the meeting. Therefore, the Applicant would respectfully request that the Staff issue their completeness letter within a reasonable time period thereafter, but no later than three business days after the Applicant files the supplement.
