I. SUMMARY

{¶ 1} The Ohio Power Siting Board cancels the certificate authority issued to Duke Energy Ohio, Inc. for failure to begin construction within two years of issuance of the certificate.

II. DISCUSSION

{¶ 2} All proceedings before the Ohio Power Siting Board (Board) are conducted according to the provisions of R.C. Chapter 4906 and Ohio Adm.Code Chapter 4906.

{¶ 3} Duke Energy Ohio, Inc. (Duke) is a corporation and a person under R.C. 4906.01(A) and is certified to construct, operate, and maintain a major utility facility, in the form of a natural gas pipeline facility in Hamilton County, Ohio.

{¶ 4} R.C. 4906.04 provides that no person shall construct a major utility facility in the state without obtaining a certificate for the facility from the Board.

 $\{\P 5\}$ R.C. 4906.03(F) instructs the Board to adopt rules that provide for an accelerated review and automatic certification of a gas pipeline not more than five miles in length or needed to meet the requirements of a specific customer or specific customers. In accordance with R.C. 4906.03(F), the Board has adopted rules addressing accelerated certificate applications.

{¶ 6} On May 7, 2015, the Board approved an accelerated letter of notification (LON) certificate application to construct a 12-inch, 1.3 mile gas pipeline to the Miami Fort Generating Station in Hamilton County filed by Duke in Case No. 15-94-GA-BLN, pursuant to then applicable Ohio Adm.Code 4906-5-02.¹

{¶ 7} Pursuant to Ohio Adm.Code 4906-5-02(A)(4), if a continuous course of construction had not commenced within two years of the LON approval date, the Board's approval of the LON project automatically expired.

{¶ 8} To date, Duke has taken no action under the LON certificate to commence a continuous course of construction on the Miami Fort Generating Station project.

{¶ 9} Based on Duke's failure to begin a continuous course of construction within two years as authorized, the Board finds that Duke's authority under the certificate should be canceled and that Case No. 15-94-GA-BLN should be dismissed and closed of record.

III. ORDER

{¶ 10} It is, therefore,

{¶ 11} ORDERED, That the authority to construct under the certificate in Case No. 15-94-GA-BLN be canceled, and that this case be dismissed and closed of record in accordance with Paragraph 9. It is, further,
