- {¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon Steven J. Dodson (Respondent) alleging violations of the Commission's transportation regulations.
- {¶ 2} On August 6, 2018, counsel for Respondent filed a request for an administrative hearing regarding the NPD as contemplated by Ohio Adm.Code 4901:2-7-13.¹ A prehearing conference held January 31, 2019, did not resolve the matter.
- {¶ 3} Accordingly, the attorney examiner sets this case for hearing on Tuesday, May 21, at 10:00 a.m., in Hearing Room 11-C at the offices of the Commission, 180 East Broad Street, 11th Floor, Columbus, Ohio 43215-3793.
- {¶ 4} At the evidentiary hearing, Staff must prove that Respondent committed the violation alleged in the NPD by a preponderance of the evidence. Ohio Adm.Code 4901:2-7-20. Following Staff's presentation of the evidence, Respondent will have the opportunity to present testimony and other evidence supporting Respondent's contentions regarding the alleged violation.
- {¶ 5} Pursuant to Ohio Adm.Code 4901:2-7-14, a respondent who has requested an administrative hearing and fails to appear for the evidentiary hearing shall be in default. A respondent in default shall be deemed to have admitted the occurrence of the violations

On September 5, 2018, counsel filed a notice of withdrawal and requested that all further communications be directed to Respondent. Meanwhile, on August 29, 2018, another attorney filed a second request for an administrative hearing regarding the same NPD, or at least regarding the same Ohio Motor Carrier Information System (OMCIS) Report No.: OH1359002536D. This second request for an administrative hearing was assigned Case No. 18-1347-TR-CVF, and a hearing in that case will be scheduled for the same date and time as the instant matter.
