




This picture was taken in summer 2017 while I was out on a drive in my Model T. I saw him/her about a quarter mile away, got up to 200 feet or so and stopped. I have several other pictures in sequence, of when this magnificent bird looked at me, picked up his/her dinner, and kept moving it step by step over to the field, so he/she could enjoy it and let me continue on by. Now, if THIS isn't nature at it's finest, I don't know what is! And, it needs to BE PROTECTED at ALL costs!

Another concern I have for renewable energy in general, is that currently it STILL IS NOT at a reliable enough stage to keep this construction up across the entire United States at this pace. One only needs to do the research throughout all of Europe and Canada to find out it has been an expensive mistake. Europe currently pays over twice per KwH as we currently do in the States. I am an all electric home, in January my bill was over \$400, and with what could very well happen as in Europe, the day will come when that will be easily \$1,000, which of course I cannot pay on my current small pension. And I'm not alone in this department.

So my take on ALL this renewable energy stuff is, it needs to "go back to the drawing board" before it continues being installed only to go "belly up", or certainly cost consumers/taxpayers billions upon billions of dollars more than they can afford.

Please, stop these current projects from happening entirely. Set the standard for the country by showing the leadership to stop it until it can be proven its worth. So far, it will never compare to Nuclear, and with todays cleaner burning "standard" power plants, there's no comparison.
