Dear Ms. Amy Acton, M.D., Interim Director OH Dept of Health:

My name is Lois Borisch. My husband, Don, and I live at 12003 Eaglescout Court, Cincinnati, 45249.

We live approximately 650 feet from where the proposed Duke Energy pipeline will be by Conrey Road. My dear friend lives even closer.

I am vehemently opposed to the plans of Duke Energy to put a 20"/500 psi pipeline in the ground at this location.

1. I do not see that Duke has adequately demonstrated a need for a transmission gas pipeline of this size for the Hamilton County needs. This area's population remains lower than it was in 1960 even with a slight uptick in growth in the last few years. In the rare case of extra need, the propane air peaking plants still have widely used technology. This definitely does not seem to be for the good of the people here, but more for Duke's interest in transmitting gas for their profit. Also, there should be a thorough and objective assessment of the case Duke is presenting. There should be other alternatives to this extreme plan.

2. I will now introduce the human safety aspect of this. I have heard that Duke does not

have to really consider human safety. This, if true, is reprehensible. Human safety should be a primary consideration of a proposed pipeline. The proposed 2 routes go through heavily populated areas – homes, schools, businesses, places of worship, and hospitals. I, personally, live way too close for comfort to the proposed pipeline. **If an accident would happen, I live in the danger zone!!!** (According to data from the Pipeline Association for Public Awareness, you should be at least 1,000 feet from a 20"/500psi pipeline at the time of a serious failure.) My neighbor's child attends Stewart School in the Princeton School District which is located on Conrey Road! This school is also in the danger zone!!! If there would be a gas leak, things like cell phones and school announcement systems should not be used. Pipelines of the size of 20"/500 psi have been put in areas of the country where they are not in populated areas. In some areas where urban sprawl has grown up around large pipelines, there have been explosions in the past injuring and killing people. Also, do we know how long this pipeline would be in the ground? With all the construction – tearing down and building up that will happen in such a populated area -- how does anyone know what might rupture a pipeline in the future? Would Duke be responsible for anything happening now or in the future?

3. More thoughts on how it can negatively affect me and others, also, financially. Some of the cost of this proposed project will be passed on to us consumers without receiving much of a benefit. Many landowners will have construction done on their land and will have restrictions on what they can do on their property. And, also, very importantly, -- if the proposed pipeline were built **it would very negatively affect the value of our homes because of the safety concerns!!!**

So, the proposed Duke Pipeline is not proved to be needed and will very negatively affect us. Thank you for your consideration of my points of concern.

Please vote **NO** on Duke Energy's Central Corridor Gas Pipeline Extension Project.

I am writing in reference to case number 16-0253-GA-BTX. I have great concerns about the need, location, and safety of the proposed pipeline.

I have attended informational meetings, presentations, and an open house hosted by Duke about the Central Corridor Pipeline Extension Project since early 2016. I have taken time to listen to Duke and educate myself on this topic. During this time, Duke has not made it clear that there is a need for the transmission line to provide service for this region. The current service in this area is more than sufficient. The transmission line will not benefit the Duke customers in this region.

But instead, it poses a significant risk to the residents, employees, and visitors near the proposed pipeline. Placing a large natural gas transmission line in a densely populated area is irresponsible. IF there is a defined need for the transmission pipeline, it should be placed in a rural area away from businesses, homes, places of worship, and schools. Safety is a big concern due to the size and pressure of the proposed pipeline. Are you willing to take on the risk and liability of approving this pipeline? Accidents happen, the risk is real.

I am concerned about the pipeline from both personal and professional aspects. One of the proposed routes would be less than 50' feet from Kinetic Vision, my place of employment in Evendale, Ohio. 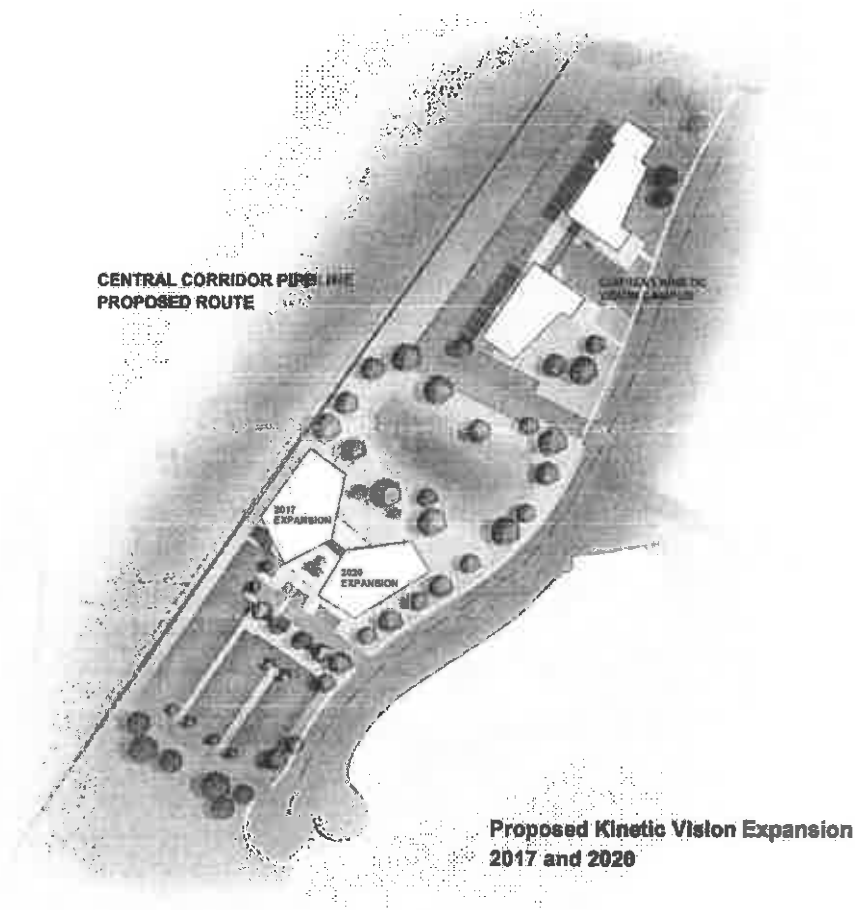

Dear M. Beth Trombold,

In 1985 I started a one-person engineering consulting business out of my Cincinnati bedroom with a one-year-old on my knee. Now, nearly 35 years later, that child is 6" taller than me and my company has grown to 140 people. Kinetic Vision provides research and development services to companies throughout the US and around the world, and we're proud to call Evendale, Ohio as our home. My talented team consists predominantly of college graduates from Ohio universities, most of whom at one time worked for us as cooperative education students while they completed their degree. We're on the cutting edge of many important technologies, including smart-product development, advanced materials, industrial scanning, virtual reality and machine learning. Our skillset diversity makes us unique among our peers.

We've built three custom facilities in Evendale as we've grown, and along with other capital expenditures, they represent about \$8,500,000 in personal investment. Our fourth building is planned for 2020.



As you are well aware, Duke Energy wants to put a 500 psi gas main right next to our campus. In fact, it will be 20-30' from our third and most recent building. This will be *extremely* detrimental to Kinetic Vision.

My employees are well aware of the dangers of natural gas pipeline explosions. Sure gas lines run under Cincinnati neighborhoods now but those are **2-50 psi, not 500**. I've personally been told that many employees will quit rather than work next to a what they feel is a ticking bomb. Those that remain will live in constant fear that a disaster could happen at any time. (Interestingly "public safety" isn't even a consideration in the pipeline route decision.) Many employees that started working for me as college students now have families of their own, and I'm faced with the prospect of a 6-year-old asking their mom or dad if they're "going to die" at work because they overheard their parents talking about the pipeline or they saw it on the news. ***This is not hyperbole; this conversation will likely happen.***

The public is well aware of the dangers of gas pipelines. *It doesn't matter whether their fear is rational or not*, the fear alone will greatly devalue the property and buildings I've spent my life savings on. What's the probability of a Three Mile Island-type meltdown with a modern nuclear power plant? I bet very low; *but would you buy a house for your family right next to it?* That's what Duke Energy is forcing on me and my employees. If allowed, my life-long efforts to build a successful business will be reduced to something of little or no value, and 140 (and soon 200) high-tech, high-paying jobs will be lost, along with the \$15 million annual tax wage base.

Unfortunately, I've been told that the Ohio Power Siting Board has *never turned down* a request like this. In my opinion that is callous and unconscionable. I only ask that you consider what you would do if your spouse, child, or grandchild was forced to work within 25' of a potential bomb. I'm an engineer myself and have worked with other engineers whose job it is to calculate risk. Privately they tell me that it's ***impossible to accurately gauge risk for anything, all they can only provide is their best educated guess based on past data.*** The best engineered things: new Boeing airplanes, space shuttles, and **yes gas pipelines, fail in disastrous ways all the time. Why not spend the extra money and place this pipeline away from where people live and work to mitigate this potential calamity?**

I implore you to consider the damage to this pipeline would cause to my company and other homes and businesses along the route. What I've spent 35 years creating could suddenly become worthless. With the investment I've made in our three (soon four) buildings I can't afford to relocate, but I also can't ask people to work right next to something they will fear every day. Please ask serious questions on whether this pipeline is even necessary, and please consider the men, women and children whose lives will be affected by it. Thank you for listening.

I am writing today to ask you to forbid Duke Energy from building the Pipeline extension in either of its current proposed routes.

My husband and I have already sent letters, petitions and emails to you and your predecessors for the past nearly three years.

The relevant issues include:

1. **Need** — Duke has not demonstrated sufficient need for this pipeline to the community. This is a transmission line that doesn't have any local taps, so will not benefit our communities. Duke can build a connecting pipeline in much less densely populated areas.
2. **Environmental impact** — This pipeline is planned along major commuting routes for thousands daily. The construction would be extremely disruptive. Hundreds of mature trees and all types of landscaping would be destroyed permanently. People's front yards would be decimated. After construction, the 80 foot clearance required would be a permanent scar on dozens of neighborhoods.
3. **Cost** — The rate payers in the communities would shoulder the burden of the construction and support of this pipeline. **If we don't want it and it doesn't benefit us, why should we pay for it???**
4. **Safety** — I understand that safety is not a criteria OPSB uses in making its decisions. (Now there's a change that should be made!!). However, as public servants, your **first** responsibility is to protect the citizens of the state from harm. This pipeline extension is unnecessarily harmful and unsafe!! Pay attention to your most basic responsibility!!

Citizens know there is a national natural gas pipeline system under construction. We are not opposed to this system. We are opposed to **this** pipeline in **this** location. It is densely populated, with numerous schools, places of worship, shopping centers, railways, heavy traffic patterns and hundreds of residences. Duke can build a connector to the east with far less negative impact.

Citizens also know that Duke is a business, desirous of making profits for its shareholders. At this point, it feels like Duke is dug in and waiting for public outcry to subside before it plows ahead. They could've developed other routes by now and be already making money with far less public animosity!

I am asking you to do the right thing. Do not rubber-stamp this application. Do your homework and drive these routes, as I have. Research the incidence of gasoline explosions in recent years. Listen to your constituents, please! It is our welfare at stake.



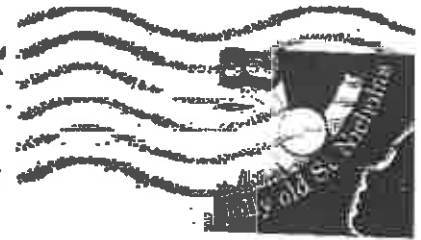

My name is Lois Borisch. My husband, Don, and I live at 12003 Eaglescout Court,
Cincinnati, 45249.

We live approximately 650 feet from where the proposed Duke Energy pipeline will be
by Conrey Road. My dear friend lives even closer.

I am vehemently opposed to the plans of Duke Energy to put a 20"/500 psi pipeline in
the ground at this location.

1. I do not see that Duke has adequately demonstrated a need for this
transmission size pipeline for the Hamilton County needs. This area is not
growing, but actually decreasing in population. In the rare case of extra need, the
propane air peaking plants still have widely used technology. This definitely does
not seem to be for the good of the people here, but more for Duke's interest in
transmitting gas for their profit. Also, there should be a thorough and objective
assessment of the case Duke is presenting. There should be other alternatives to
this extreme plan.

2. I will now introduce the human safety aspect of this. I have heard that Duke does not have to really consider human safety. This, if true, is reprehensible. Human safety should be a primary consideration of a proposed pipeline. The proposed 2 routes go through heavily populated areas – homes, schools, businesses, places of worship, and hospitals. I, personally, live way too close for comfort to the proposed pipeline. If an accident would happen, I live in the danger zone!!! (According to data from the Pipeline Association for Public Awareness, you should be at least 1,000 feet from a 20"/500psi pipeline at the time of a serious failure.) My neighbor's child attends Stewart School in the Princeton School District which is located on Conrey Road! This school is also in the danger zone!! If there would be a gas leak, things like cell phones and school announcement systems should not be used. Pipelines of the size of 20"/500 psi have been put in areas of the country where they are not in populated areas. In some areas where urban sprawl has grown up around large pipelines, there have been explosions in the past injuring and killing people. Also, do we know how long this pipeline would be in the ground? **With all the construction – tearing down and building up that will happen in such a populated area, how does anyone know what might rupture a pipeline in the future? Would Duke be responsible for anything happening now or in the future?**

3. More thoughts on how it can negatively affect me and others, also, financially. Some of the cost of this proposed project will be passed on to us consumers without receiving much of a benefit. Many landowners will have construction done on their land and will have restrictions on what they can do on their property. And, and very importantly, -- if the proposed pipeline were built it would very negatively affect the value of our homes because of the safety concerns!!!

So, the proposed Duke Pipeline is not proved to be needed and will very negatively affect us. Thank you for your consideration of my points of concern.

Please vote **NO** on Duke Energy's Central Corridor Gas Pipeline Extension Project.

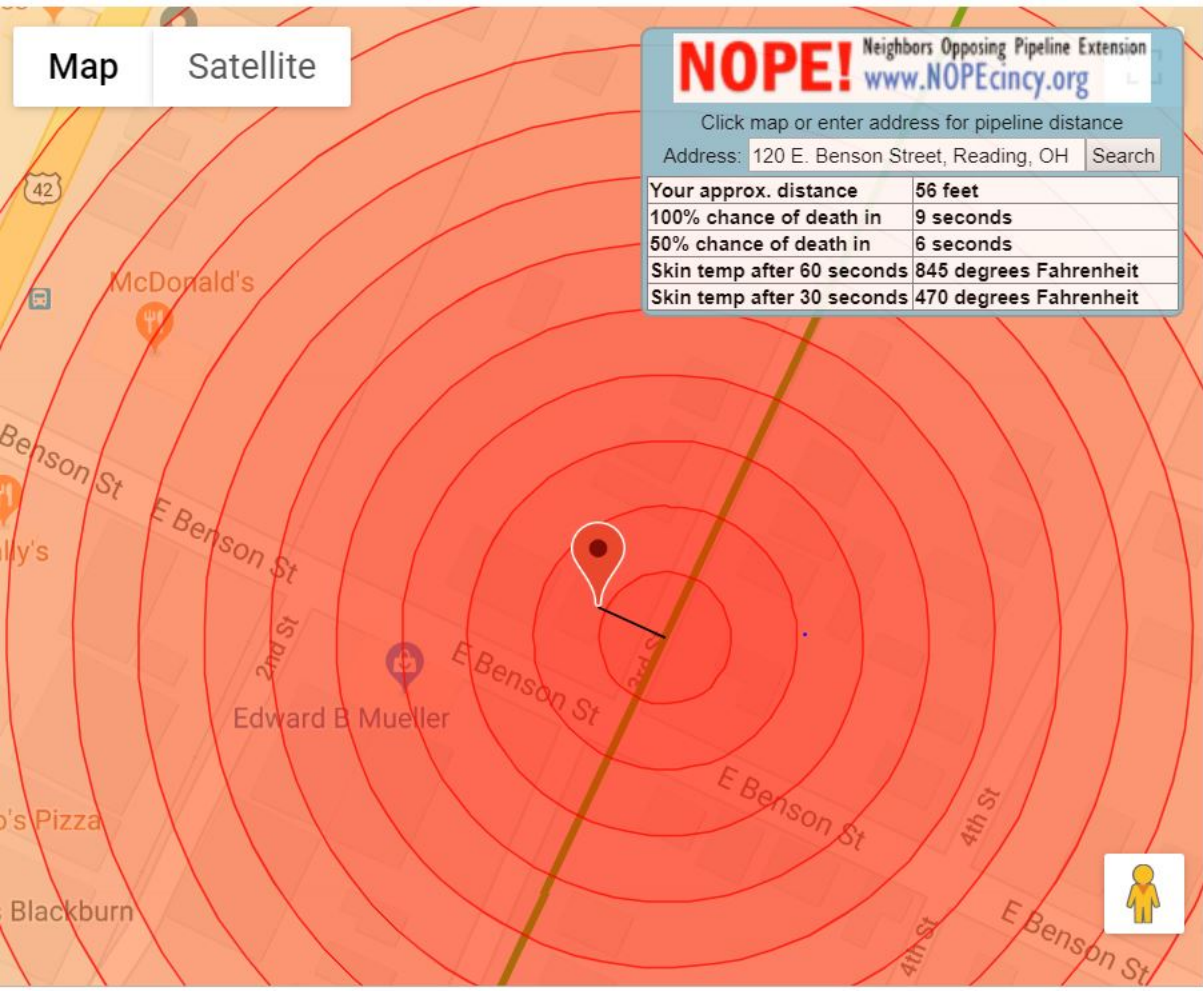
