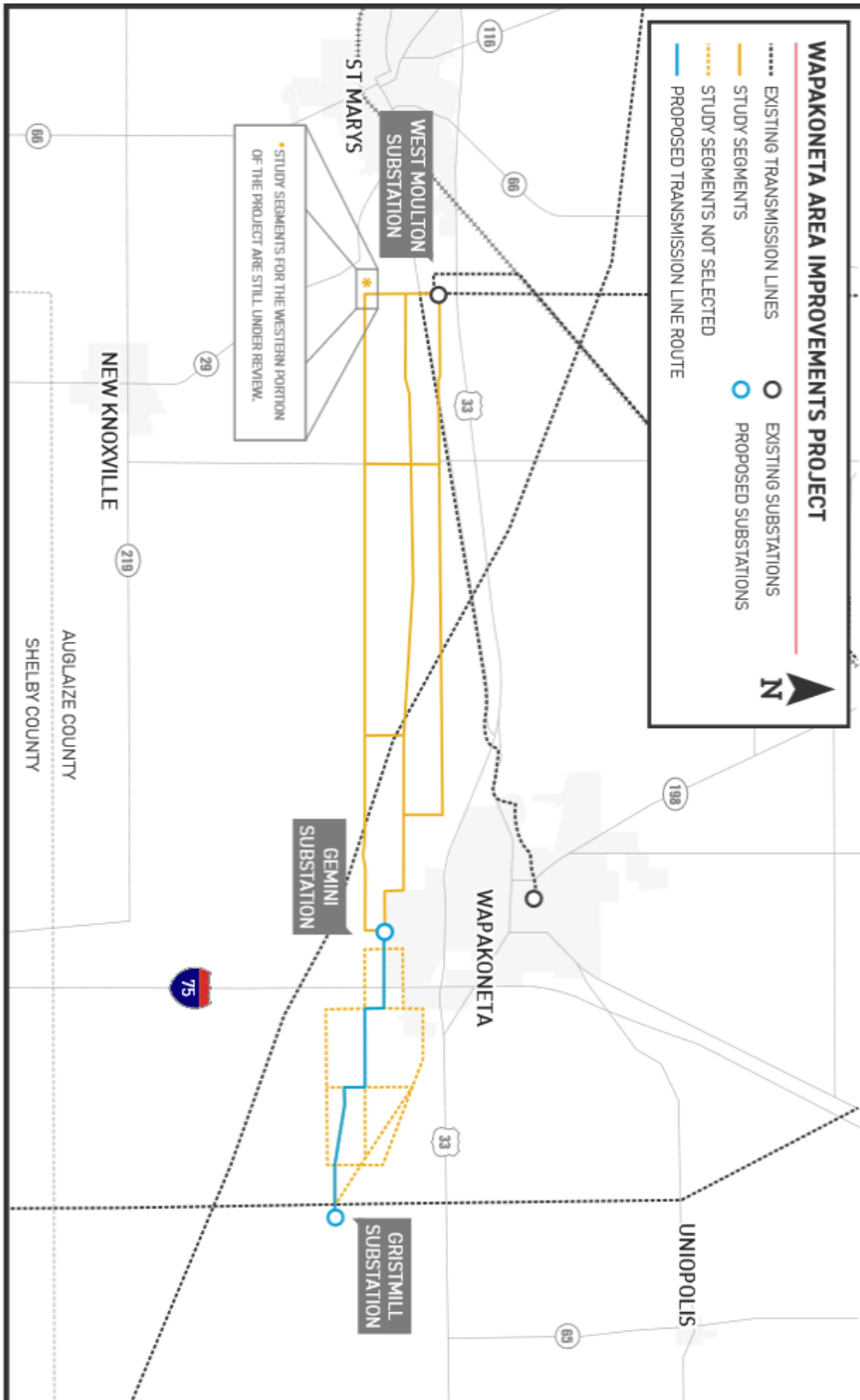

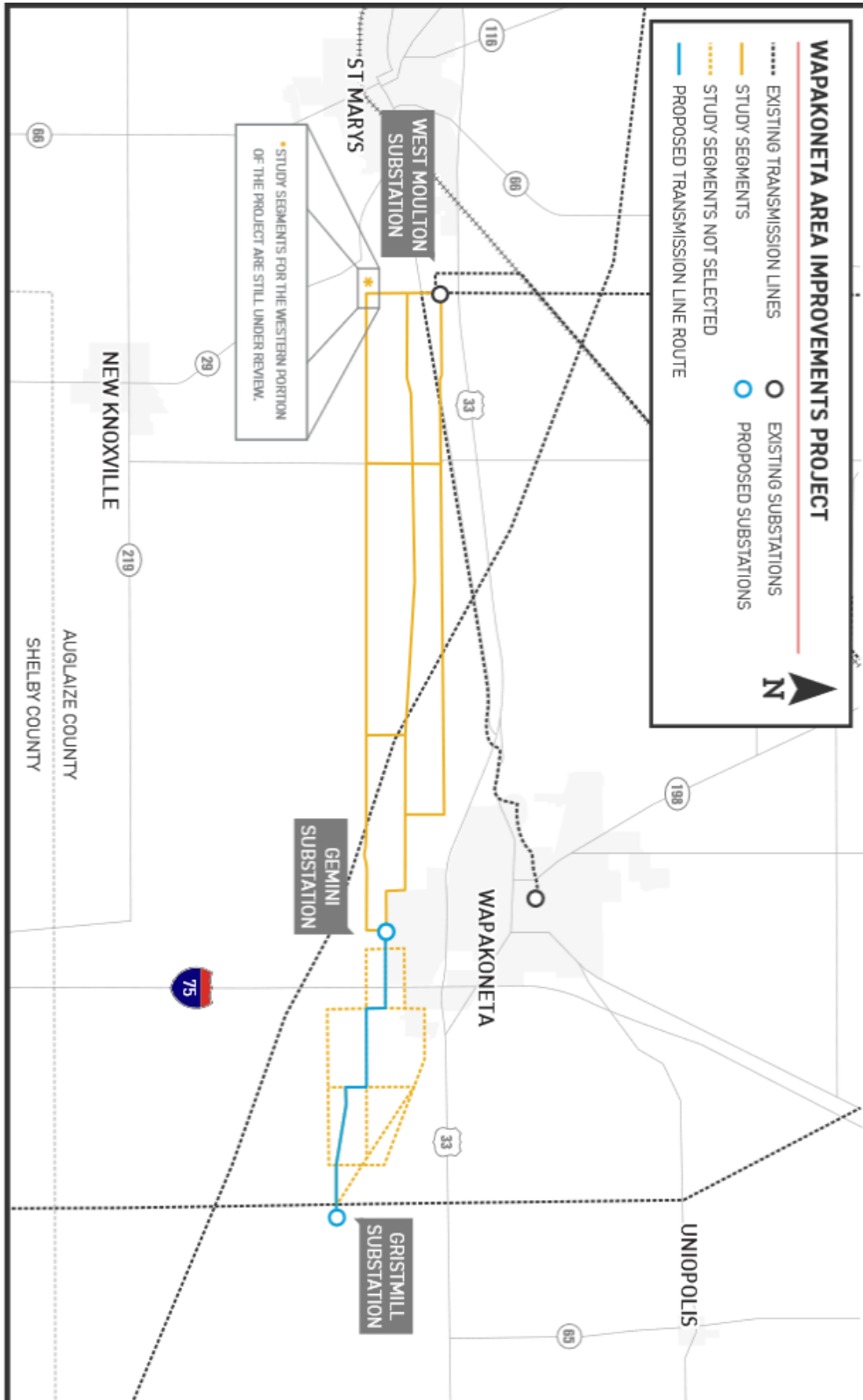

# Sustainable farming becoming more prevalent in US

The St. Marys Community Public Library held the first of five of their installments on sustainability Thursday evening. Although there was a small crowd, that didn't stop Technology Coordinator Angela Karen from talking about sustainability as it relates to food and agriculture - a topic common to Auglaize County which is home to more than 1,000 farms according to the 2012 census.

Karen mentioned that sustainability trends are becoming more and more popular in today's society. While some practices are more popular in Europe, she did say that some practicing are starting to get picked up in America, more specifically in the larger farms in the western part of the country.

One reason for the growing sustainability efforts, Karen mentioned, is climate change.

"Whether you believe it is human made or natural processes the planet goes through we still need to think about sustaining our lives and thinking of the future and planning ahead for survival of the species whether it is manmade disasters or natural catalysms," she said.

Another need is because of the over use of the soil and the erosion that is hap-

pening as a result of a higher demand for food with population increases. She cited that in the 1990s farmers, on average, were feeding 126 people per year. Since then the population has increased thus increase the number of mouths to feed.

And while farming has seen increases in productions because of industrialization, an increase in produce like vegetables and fruits more readily available year round and items like coffee, tea and cocoa more accessible downfalls exist as well. Starvation still exists, especially in underdeveloped countries, as well as pollution as a result of the industrialization and food and safety concerns because of the use of pesticides and chemical fertilizers.

Through sustainability efforts, Karen mentioned individuals can help protect themselves from any worries they may have about the food they purchase, as well as how they can lower their waste amounts and plastic use.

One such means for consumers, Karen mentioned, was self growing of produce with growing of microgreens as well as creating aquaponics and hydroponic systems.

"Like you would grow your basil, but the micro-green version you actually only grow it for six weeks

and then you use it in your salads and it uses less soil and less water but you have in the smaller amount you have the more nutrient dense plants in there," she said.

She added there are kits people can buy with step-by-step instructions on how to grow the microgreens. Most of the kits are made to grow salad greens but can also grow items like cauliflower, cabbage, broccoli, mustard seeds and other herbs and spices.

For those who are up for more of a challenge and are interested in the science side of food production, hydroponic and aquaponic systems are available as well.

"In your house you would have a small fish tank and then you would have your plants growing above and there's different companies that sell kits and so all you have to do is you order the kit, it comes in the mail, you assemble it, you follow all their step-by-step instructions and you have a little aquaponics in your house for lettuce and herbs," Karen explained. "There are countertop models up to bigger scaled models."

She mentioned that with the aquaponics, it is similar to creating a self sustaining ecosystem that feeds off of itself. Small to large fish can be added to the tanks to make that possible.

"There is a list of a the best

fish to have in there and then there is from Koy fish to Salmon to Perch," she said of the larger tanks. "After awhile you could eat the fish and breed some new fish and have your own little ecosystem going there.

"And those aren't cheap either, you're looking at a few \$100 to a few \$1,000. But if you like your fish, a fish tank — you can have a small fish tank for \$10 up to thousands and thousands of dollars."

The hydroponics don't use fish and requires a system of water running through the system. There isn't a need for a lot of soil, but the pH levels need to be closely monitored which may be more for those interested in the science behind agriculture, Karen said.

With lowering waste products, Karen showed attendees ways other countries, and even some companies, are attempting to lower the use of plastic in the world.

Karen mentioned that some companies are working to cut back on plastic use — something she says our society as a whole has become very used to having and almost cannot function without — by using silicon based reusable products to replace them long-term.

One trend she said she's noticed is one that is stray-

ing away from one-use plastic bags. She said reusable silicone bags are becoming more popular to replace the small plastic bags often used in packed lunches. Packs of five of the silicone bags can be purchased off Amazon for \$25, she showed, and while customers won't get as many as they would with the plastic, the silicone bags last longer than the non-reusable form. Reusable straws and shopping bags were also mentioned as a way to keep plastic use down.

In Sweden Karen showed that they transitioned to recycling almost 100 percent of their waste, including the burning some of it to make fuel. She also cited Puerto Rico as a country that is trying to go green after large amounts of trash washed up on their shore lines.

She wrapped up the session by reading a quote from American Philosopher Aldo Leopold.

"Quit thinking about decent land-use as solely an economic problem," Leopold said. "Examine each question in terms of what is ethically and esthetically right, as well as what is economically expedient. A thing is right when it tends to preserve the integrity, stability and beauty of the biotic community. It is wrong when it tends otherwise."
