On April 5, 2019 the attorney examiner issued an Entry in this case establishing May 10th, 2019 as the due date for comments in this proceeding. Staff has compared the results of the compliance review conducted by the Auditor in the subsequent 2018 DCR Annual Compliance Audit (18-1542-EL-RDR) with the recommendations made in this audit and has confirmed that all the recommendations made by the Auditor in this audit have been implemented except for two: the TCJA related recommendations, which have been addressed in the Stipulation pending in Case No. 18-1604-EL-UNC, and the accounting treatment of expenses related to vegetation management. Therefore, Staff's comments are directed solely at the recommendation made by Blue Ridge Consulting (the Auditor) regarding the capitalization policy of the Companies with respect to vegetation management. Staff supports the recommendations made by the Auditor.
