The Staff of the Public Utilities Commission of Ohio (“Staff”), pursuant to Rules 4901-1-12 and 4901-1-13 of the Ohio Administrative Code (O.A.C.), respectfully requests an extension of the filing deadline for comments. The March 25, 2019 Entry stated that “interested persons wishing to file comments regarding the application shall file those comments no later than May 24, 2019.” As of the filing of this motion, the application is still under review and more time is needed for Staff to perform a thorough plant in-service investigation review. In order to allow Staff the needed time to complete its review, Staff is requesting an extension of the deadline for filing comments to July 15, 2019. Staff is also requesting that the Commission grant this motion on an expedited basis pursuant to O.A.C. 4901-1-12(C).
