As the project continues to develop we are proposing minor adjustments to the approved power line route near the Heppner Substation.

We have filed the updated route with the OPSB as Adjustment #2 to Heppner-Rhodes 138 KV Transmission Line Rebuild Project, Case No. 19-0971-EL-BNR. This is required whenever we make certain changes to our transmission facilities, according to Rule 4906-6-01, et. seq., of the Ohio Administrative Code. Please make the Construction Notice available to the public.


