As the project continues to develop we are proposing minor adjustments to the approved power line route near the Heppner Substation.

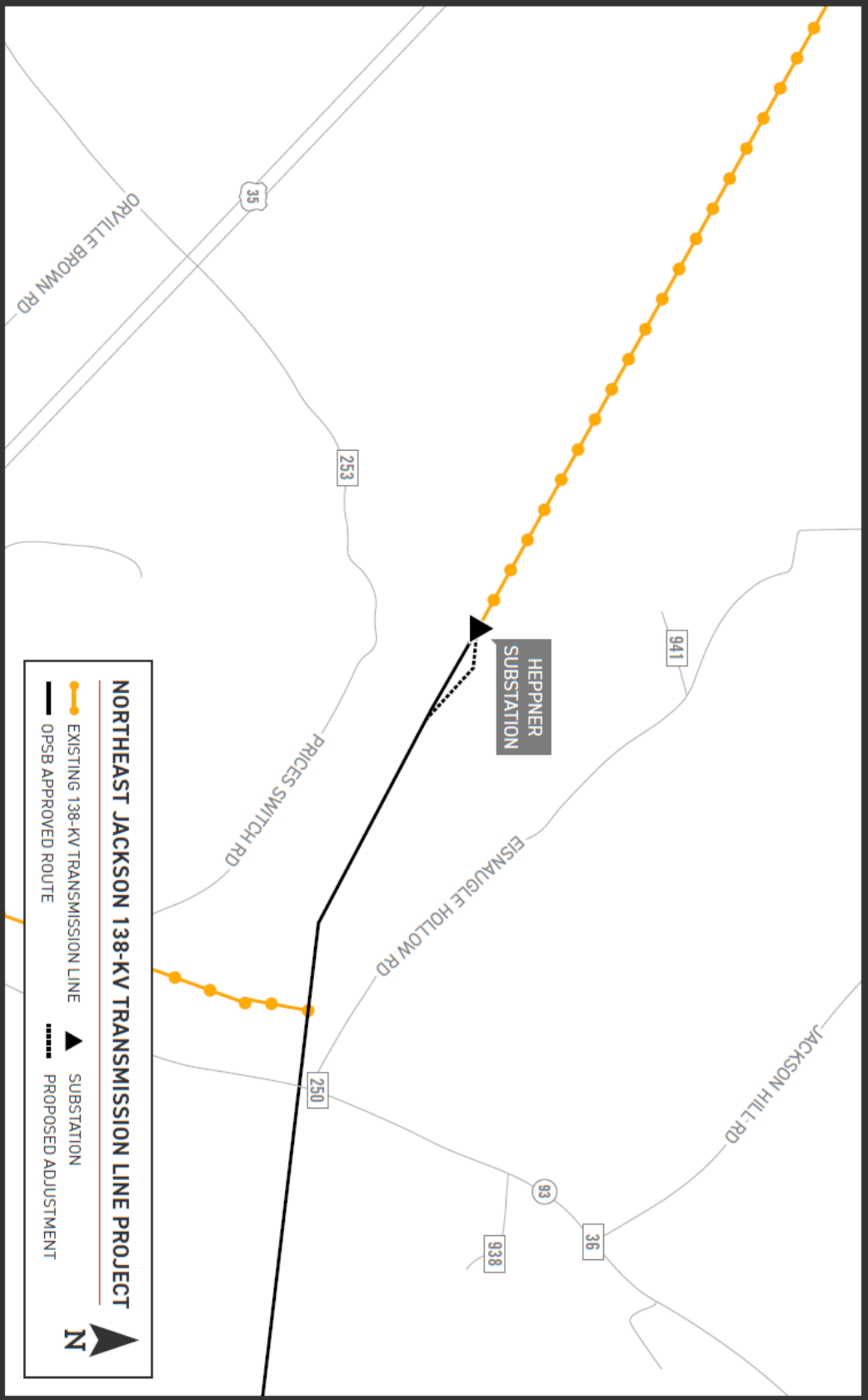
