MEMORANDUM IN SUPPORT

The Staff respectfully requests a continuance of the administrative hearing that is currently scheduled for June 4, 2019 at 10:00 a.m. in this case to begin on July 8, 2019. Staff also requests an extension of the testimony due date from May 29, 2019 to July 1, 2019. The parties are currently engaging in settlement negotiations and request more time in order to fully pursue resolution of all issues in the case. The Staff Report was filed on May 10, 2019 and the parties began discussing resolution of the matters after that date; however, additional time will provide a greater opportunity to resolve the entirety of issues in the case. For the foregoing reasons, the Staff asks that the Attorney-Examiner grant Staff's unopposed motion for a continuance of the administrative hearing from June 4, 2019 to July 8, 2019 and date for filing testimony from May 29, 2019 to July 1, 2019.
