When building aggregation groups with commercial accounts it is more important to be able to look at all the options for the clients b/c sometimes aggregating a price results in higher overall costs. A perfect example of this is when I aggregate a large church group that has multiple sites in multiple utilities. If I were to aggregate all those accounts for the church group, the facilities in Ohio Edison area end up with an overall higher rate because costs in the illuminating company service area are higher that Ohio Edison therefore doing a disservice to my client. Instead I aggregate the Ohio Edison accounts together with one supplier then bid out the illuminating company accounts individually to obtain the best rates possible through alternative suppliers that can operate at a lower cost in that specific utility. Another example would be a restaurant group I just did recently, they have 5 commercial accounts in CEI and 1 in AEP. I grouped the CEI accounts together for a total annual load of 1.8/Mwh and secured than in a longterm fixed rate to ensure we mitigate their risk and lock in some very attractive electric rates. As for the AEP account since it was a new build we used historical data from the CEI accounts to build a Performa so that we could design an energy purchasing program for the new location so the supplier would not have to build in additional risk premiums to the price.
