Please docket the comments provided in the case number above.

Once again. Ohio Edison blocks municipalities adoption of energy saving LED street lighting by egregious terms and prices in their proposed Sheet 34 LED tariff for 2020.

(1) continued use of its system-wide net book value for legacy HPS inventory to set the \$228, now \$209 proposed, OTC for "asset cost recovery" continues to disadvantage older municipalities whose legacy HPS inventory installed many years ago has a net book value near or at \$0

(2) the proposed tariff raises the fixed monthly cost of a 50W LED from today's \$6.44 by 18% to a new cost of \$7.49. This, despite continued market price declines in the LED industry from technology and volume learning curve benefits

OE's sister companies, First Energy of PA, have NO one-time-charge for LED replacements. Indiana is installing LED streetlights at the rate of 10's

of thousands yearly.

It is time that Ohio's PUCO "mans up" and stands up for the benefit of municipal taxpayers and the cause of energy efficiency, instead of paying mere "lip service"
