MEMORANDUM IN SUPPORT

The Staff respectfully requests a continuance of the administrative hearing that is currently scheduled to begin July 8, 2019 at 10:00 a.m. to commence on August 6, 2019. Staff also requests an extension of the testimony due date from July 1, 2019 to July 30, 2019. The parties are currently engaging in settlement negotiations and request more time in order to fully pursue resolution of all issues in the case.
