- A. My name is Andrew Conway. My business address is 180 E. Broad Street,

- A. I am employed by the Public Utilities Commission of Ohio (Commission).

- 8 3. Q. Please describe your job title and duties?
- A. I am employed as an Engineering Specialist in the Siting, Efficiency, and
- 10 Renewable Energy Division of the Rates and Analysis Department. In this
- position, I review technical issues associated with energy efficiency
- applications, renewable energy applications, assigned areas in Applications
- for a Certificate of Environmental Compatibility and Public Need to
- construct major utility facilities and economically significant wind farms,
- and other duties.

- 17 4. Q. Would you briefly state your educational background and work history?
- 18 A. I have a Bachelor of Science degree in Chemical Engineering and minor in
- 19 Chemistry from the University of Toledo. I am also a registered professional
- engineer in the State of Ohio. I attended a Solar Photovoltaic Project Design
- and Development workshop in August 2016. I also successfully completed

1			the Electronics Technicians Association (ETA) certified 5-day Photovoltaic
2			Level 1 Design/Installation Course in January 2017.
3			From 2001 to 2009, I was employed by the Ohio Environmental Protection
4			Agency as an environmental specialist. From 2009 to present, I have been
5			employed in my current position at the Commission.
6			
7	5.	Q.	Have you previously testified before the OPSB?
8		A.	Yes. I previously testified in cases before the Board.
9			
10	6.	Q.	What is the purpose of your testimony in this proceeding?
11		A.	I served as the overall Staff Project Lead for the investigation that resulted in
12			the Staff Report of Investigation (Staff Report) that was filed April 15, 2019
13			in this docket. I managed the Staff investigation and preparation of the Staff
14			Report in this case. I previously filed testimony in this case on May 10, 2019.
15			Through the negotiation process, staff determined that minor changes to a
16			few of the original conditions of the Staff Report were reasonable and will
17			continue to minimize the project's environmental impact.
18			
19	7.	Q.	What type of case is this?
20		A.	The Applicant proposes to construct an 80 megawatt solar-powered
21			generating facility located in Israel and Dixon Townships, Preble County,
22			Ohio.

1 8. Q. Please summarize Staff's investigation that was conducted in this case.

A. Staff's investigation included reviewing the application, conducting site visits to the proposed facility location, acquiring additional information from the applicant, obtaining input from state agencies that compose the Board along with other relevant state and federal agencies, and preparing a Staff Report of Investigation that presents Staff's analysis, conclusions, and recommendations. As a result of Staff's investigation, Staff is recommending that the Board approve the application, subject to the 27 conditions that are presented in the Staff Report of Investigation. Furthermore, Staff agrees with and supports the modifications to the conditions as proposed in the Stipulation and the two additional conditions discussed in answer 10 below.

Q. What impacts did Staff review for the project in arriving at this conclusion?

A. Staff reviewed the ecological impacts, residential impacts, cultural resources impacts, impacts to roads and bridges, impacts to agricultural lands, geological impacts, financial impacts, noise impacts, safety impacts, impacts to the electrical grid, and the aesthetic impacts.

10. Q. Does the Stipulation include additional conditions that were not contained in the Staff Report?

A. Yes. There are two new conditions, numbered 28 and 29 added to the Stipulation. Paragraph 28 requires that the Applicant train local fire and

1			emergency service providers how to respond to emergency or fire situations
2			that could occur at the project. The other additional condition details
3			requirements for decommissioning the project. I believe these conditions are
4			reasonable and do not have any effect on the project's environmental impact.
5			
6	11.	Q.	Does this conclude your testimony?
7		A.	Yes, it does. However, I reserve the right to submit supplemental testimony,
8			as new information subsequently becomes available or in response to

positions taken by other parties.
