## **MEMORANDUM IN SUPPORT**

Taylor Energy Partners, LLC (“Taylor Energy”) hereby requests an extension of its Certificate Number 17-1237(E)(1), pursuant to Admin. Code 4901:1-24-04, during the pendency of its new application for certification. Taylor Energy’s certificate became effective on June 23, 2017 and expired on June 23, 2019.

Rule 4901: 1-24-04 provides in pertinent part:

Any CRES provider or governmental aggregator that fails to file an application for certification renewal pursuant to rule 4901:1-24-09 of the Administrative Code prior to the expiration date on the certificate must file a new application for certification in a new case and may request, no later than sixty days after the expiration date on the certificate, to extend its previous certificate during the pendency of the new application review

Under Admin. Code 4901:1-24-04, Taylor Energy’s Renewal Application was not filed prior to the expiration date of the certificate due to administrative error. Taylor Energy will file a new Certificate Application and requests the existing certificate be extended until the renewal application is approved.

For all the foregoing reasons, Taylor Energy Partners, LLC respectfully requests that its Certificate Number 14-771(E)(2) be automatically extended as permitted in Rule 4901:1-24-04
