## **MEMORANDUM IN SUPPORT**

Broadway Energy Group Corp. (“Broadway Energy”) hereby requests a thirty (30) day extension of its Certificate Number 15-981E, pursuant to Admin. Code 4901:1-24-09(A). Broadway Energy’s certificate became effective on June 13, 2017 and expired on June 13, 2019. Broadway Energy filed its renewal application on June 12, 2019.

Rule 4901: 1-24-09 provides in pertinent part:

If the provider files such renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty calendar days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion.

Under Admin. Code 4901:1-24-09, Broadway Energy’s Renewal Application was due to be filed no less than thirty (30) days prior to the expiration date indicated on its provider certificate, or May 13, 2019. Broadway Energy has filed its Renewal Application less than thirty (30) days prior to the expiration date on its certificate due to administrative error, and requests the existing certificate be extended until the renewal application, filed on June 12, 2019, is approved.

For all of the foregoing reasons, Broadway Energy Group Corp. respectfully requests that its Certificate Number 15-981E be automatically extended for thirty (30) days as permitted in Rule 4901:1-24-09(A).
