Dear Ms. Turkenton and Ms. Troupe:

This letter serves as The East Ohio Gas Company d/b/a Dominion Energy Ohio's ("Applicant" or "DEO") pre-application notification letter in order for the Ohio Power Siting Board ("Board") to open a case for 1250 S. Washington Street Betterment (2019) Pipeline Replacement Project Van Wert County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Construction Notice.

In accordance with Ohio Administrative Code ("OAC") 4906-6-03(A), DEO provides the following information:

**Project Description:** DEO is planning to replace approximately 1,200 feet of existing 4-inch diameter pipeline with 12-inch diameter pipeline within the public road right-of-way ("ROW"). The pipeline will run approximately 1,200 feet on Lincoln Highway in a west to east direction between 10812 Lincoln Highway and John Brown Road, City of Van Wert, Van Wert County, Ohio. The primary purpose of the replacement is to meet the additional gas demand from Van Wert Hospital on 1250 South Washington Street.

**Anticipated Project Schedule:** The construction of the pipeline is anticipated to begin the fall of 2019. DEO plans to place the line in-service by the end of 2019.

**Expedited Treatment:** DEO requests expedited treatment for this application, and will submit payment of \$2,000.00 in accordance with OAC 4906-6-04(A)(2).
