RIDER DMR <u>Distribution Modernization Rider</u>

APPLICABILITY:

Applicable to any customer who receives electric service under the Company's rate schedules. This Distribution Modernization Rider (DMR) will be effective for service rendered beginning October 1, 2019. This Rider is not avoidable for customers during the period the customer takes electric generation service from a certified supplier.

The DMR credits will apply, by rate schedule, as follows:

RIDER UPDATES:

The charges contained in this Rider shall be updated on an annual basis. No later than December 1st of each year, the Company will file with the PUCO a request for approval of the Rider charges which, unless otherwise ordered by the PUCO, shall become effective on a service rendered basis on January 1st of each year. This Rider is subject to refund only if the Supreme Court of Ohio denies the Company's Motion for Reconsideration filed on July 1, 2019 in Consolidated Case Nos. 17-1444 & 17-1664, or issues a mandate instructing that Rider DMR be removed from the Company's ESP. Any refund is limited to billings beginning on the date this update is approved by the Commission.
