I regret I am not able to attend this wonderful event today at the Runnymede Library. Please note that we would deeply appreciate Maude's statement to include the exclusion forever of industrial wind turbines from the Great Lakes, and within as American Bird Conservancy says, ten miles of the perimeter. The Lakes are after all, one of the most magnificent bottlenecks of migration, water for millions on millions of creatures including people.

Please see attached a letter we recently sent to the IJC, President Trump, Prime Minister Justin Trudeau, and others. Please also note the letter from Rich Davenport, urging a moratorium for turbines in the Lakes. This excellent letter is referenced in the IJC letter.

We really must protect the Lakes, 20 % of the world's remaining fresh water.

Each turbine contains upwards of 400 gallons of oil and lubricants, which leaks, and must be replenished. The blades are non recyclable carbon fibre, and on land are beginning to fill up land fills.

We are currently fighting a project off of Cleveland, six massive turbines proposed for Lake Erie....the developer sees Lake Erie as an open field for thousands more. Has said so repeatedly. Please see <http://www.greatlakeswindtruth.org>

Here are a few pictures so that you will remember to mention NO TURBINES in the Lakes! Please also remember that Ontario has an offshore moratorium, not likely to be lifted any time in the next hundred years. Communities have rigorously fought any idea of turbines in the fresh water of the Lakes, and


