You are receiving this letter because you own property or live in the area that's part of AEP Ohio's Glencoe-Speidel 138kV Transmission Line Project. I'm writing to provide an update about the project, which involves upgrading about 13 miles of 69-kilovolt (kV) power line to 138-kV standards. The line travels through Smith, Goshen and Warren townships in Belmont County and is necessary to ensure the continued reliability of the electric transmission system.

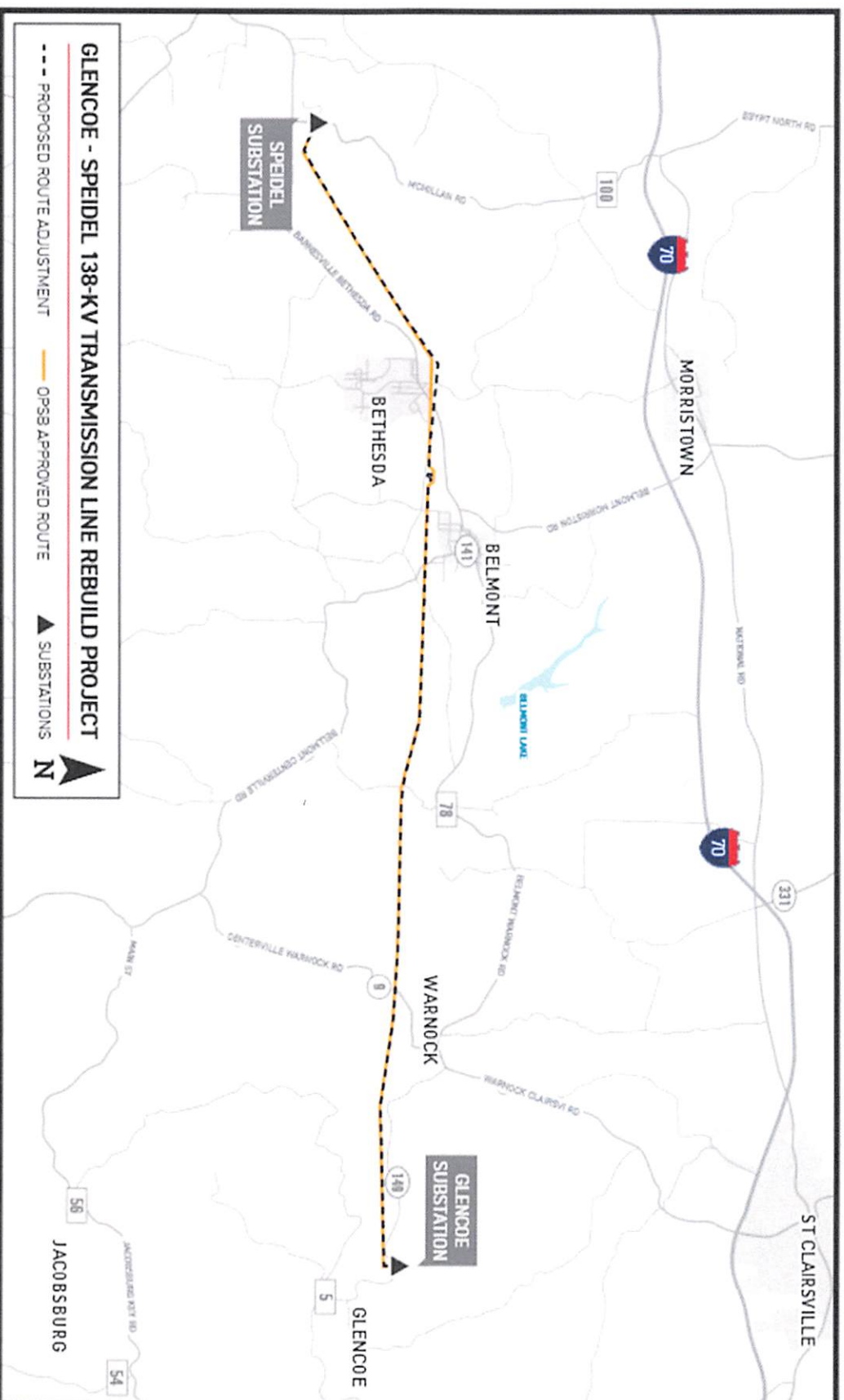
AEP Ohio filed the enclosed amendment with the Ohio Power Siting Board (OPSB) on September 20, 2019 that includes minor changes to an application we previously submitted for the project on June 13, 2018. Since we submitted that application, the following events have taken place leading up to the recently filed amendment:

- The OPSB certified the application as complete on August 13, 2019 based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1).
- The OPSB approved the application on February 21, 2018 under Case No. 18-0279-EL-BTX.
- The OPSB issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred power line route.
- AEP Ohio proposed adjustments to the approved power line route.
