You are receiving this letter because you own property or live in the area that's part of AEP Ohio's Dennison-Yager 138kV Transmission Line Project. I'm writing to provide an update about the project.

AEP Ohio filed the enclosed amendment with the Ohio Power Siting Board (OPSB) on July 12, 2019 that includes minor changes to an application we previously submitted for the project on July 22, 2016. Since we submitted that application, the following events took place leading up to the recently-filed amendment:

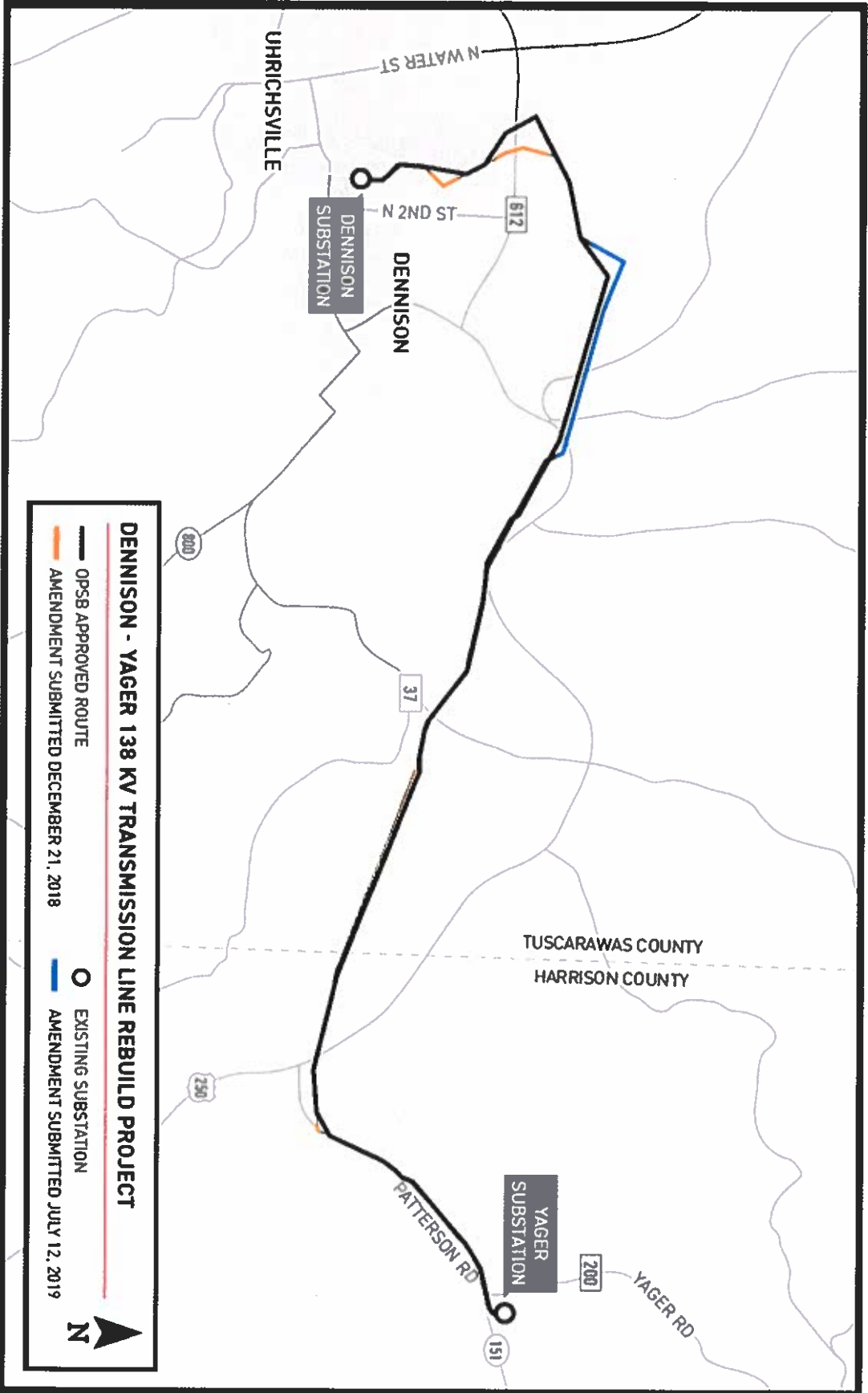
- The OPSB certified the application as complete on September 20, 2016 based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1)
- The OPSB approved the application on May 4, 2017 under Case No. 16-0534-EL-BTX
- The OPSB issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred power line route.
- As the project continues to develop, we have proposed adjustments to the approved power line route. We have filed two separate amendments with the OPSB.
 - We submitted the first amendment on December 21, 2018.
 - We submitted the second amendment on July 12, 2019.

Plans involve building approximately 7 miles of power line between the Dennison Substation in Tuscarawas County and the Yager Substation in Harrison County. The project helps ensure electric service reliability and supports economic development.


