You are receiving this letter because AEP Ohio proposes to rebuild a power line in Belmont, Guernsey and Noble counties.

Plans involve rebuilding approximately 16 miles of power line between the Barnesville and Summerfield substations. The project helps ensure electric service reliability and supports economic development.

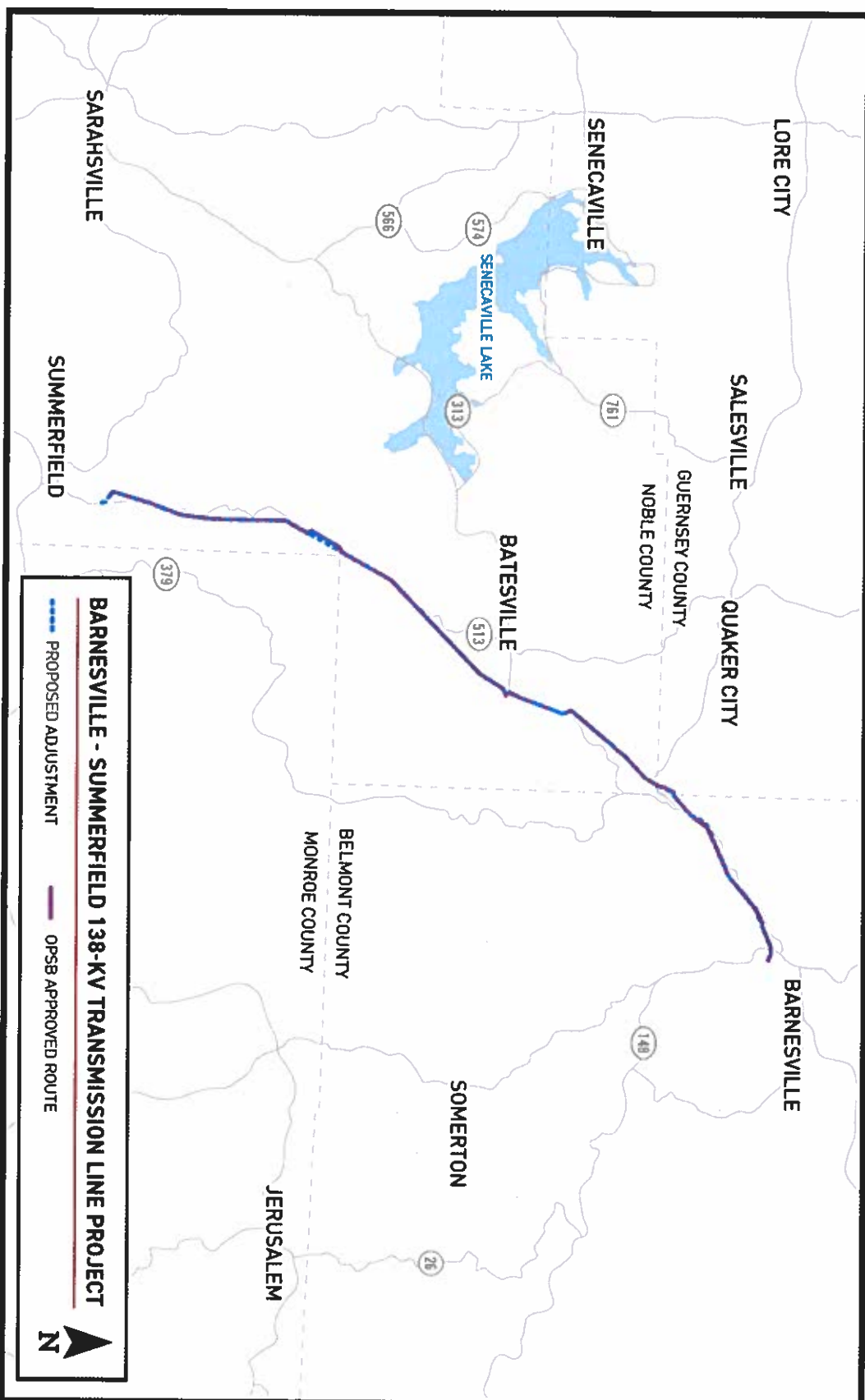
We submitted an application to the Ohio Power Siting Board (OPSB) for this project on July 1, 2016. The OPSB certified this application as complete on August 30, 2016, based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1). On February 2, 2017, the OPSB approved this application under Case No. 16-0438-EL-BTX and issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred power line route.

We filed the enclosed amendment with the OPSB on May 21, 2019 that includes minor alignment shifts to the route. Copies have also been distributed to local government officials, the local public library and property owners in the project area.
