NOTICE OF WITHDRAWAL OF COUNSEL

Pursuant to Rule 4901-1-08 of the Ohio Administrative Code, notice is being given to the Public Utilities Commission of Ohio and to all parties of record that Miranda Leppla is withdrawing as counsel for Environmental Law & Policy Center (ELPC) in Case Nos. 18-1875-EL-GRD and 18-1876-EL-WVR. Furthermore, notice is hereby provided that Miranda Leppla will remain as counsel for Ohio Environmental Council and Environmental Defense Fund, and that Nikhil Vijaykar, who has already filed an appearance in this proceeding, shall be designated as Counsel of Record for ELPC.

18-1875-EL-GRD and Case No. 18-1876-EL-WVR, so that all three dockets reflect the withdrawal of Miranda Leppla as counsel for ELPC.
