1. That it is the duly elected body authorized to act for Richmond Township, Huron County, Ohio and has taken the required action to intervene, as certified by the attached resolution adopted at a special public meeting held on October 1, 2019;
2. That it is a party authorized to intervene pursuant to R.C. 4906.08;
