On March 15, 2018, the Ohio Rail Development Commission (ORDC) authorized funding for Norfolk Southern Railway to install active warning devices at Bayard Road/TR 703 DOT#544-856J in Columbiana County, Ohio. The crossing was surveyed, on October 13, 2017, and found to warrant the upgrade.

On October 10, 2018, the Commission approved the project and ordered completion by October 10, 2019.

On September 26, 2019, NS filed for an extension until January 30, 2020 (see attached). In the request, NS states that they have continued delays due to PTC (Positive Train Control) projects and that labor force restrictions do not allow them to begin work on the project. They are working on redirecting crews and expect to place the crossing in service by January 30, 2020.

Staff believes that NS has failed to show that good cause exists to grant additional time for completion of the project. Staff does not recommend a project extension.

MEMORANDUM IN SUPPORT

By Finding and Order of October 10, 2018, NSRC was authorized to install active warning devices at the Bayard Road grade crossing, with an original construction deadline of October 10, 2019.

Notwithstanding concerns raised with PUCO Staff previously (re the approaching, federally-mandated PTC deadline, and related seniority district/crew concerns), NSRC is redirecting its crews toward this crossing, and expects that it will be able to place the crossing in-service by January 30, 2020, if not sooner.
