**NOTICE OF ISSUANCE OF REFUND**

---

On September 26, 2019, the Commission issued an Order in this case directing Pike Natural Gas to refund to its current GSR and GSC customers the accrued DSM funds, by way of a one-time bill credit, within 30 days, and provide notice to affected customers (Paragraph 23 of the Order).

The Commission further Ordered that Pike file notice of the issuance of the refund with the Commission, within 14 days after the bill credit is issued to all GSR and GSC customers (Paragraph 24 of the Order).

On October 3, 2019 Pike complied with the Order and refunded the accrued DSM funds, by way of a one-time bill credit to its current GCR and GSC customers.
