Dear Ms. Turkenton and Ms. Troupe:

On October 7, 2019, Seneca Wind, LLC ("Applicant") filed a pre-application notification letter with the Ohio Power Siting Board ("OPSB") for its proposed wind farm, which will result in a total generating capacity of up to 212 megawatts ("MW"). This letter serves as a supplement to the pre-application notification letter.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-3-03(A), Applicant provides the following information:

Project Description. The project will be built on approximately 25,000 acres of leased private land in Scipio, Reed, Venice, Eden, and Bloom Townships, Seneca County. The wind farm will consist of up to 77 wind turbine generators, along with access roads, electric collection cables, a substation, a laydown yard for construction staging, an operations and maintenance facility, and two meteorological towers. The nameplate capacity rating of these wind turbine generators ranges from 2.0 to 3.6 MW, depending on the final turbine models selected. The total generating capacity of the wind farm will not exceed 212 MW. The energy generated at the wind farm will deliver power to a single point of interconnection (POI) on the AEP Melmore 138 kilovolt (kV) transmission line. The general purpose of the project is to produce environmentally clean, reliably priced, low cost electricity to the Ohio electric marketplace. Construction of the project is projected to begin in October 2020, with projected commercial operation beginning in August 2021.

The Applicant plans to hold a public information meeting on Wednesday, October 23, 2019 from 3:00 p.m. to 6:00 p.m. at the Attica Fairgrounds Social Hall, 15127 East Township Road, Attica, Ohio 44807. The Applicant informed the OPSB Staff of the meeting.

Anticipated Waivers. Pursuant to OAC Rule 4906-3-03(A), Applicant does not anticipate seeking any waivers from the Board's filing requirements based on the information currently known. However, the Applicant reserves the right to seek a waiver if circumstances change in the future.
