14 15	Q.1.	Please state your name and home address.
16	A.1.	Dawn Hoepf, 4600 North State Route 19, Republic, OH 44867.
17	Q.2.	On whose behalf are you offering testimony in this case?
18	A.2.	I am offering testimony on behalf of Intervenors Joseph & Diane Anderson, Denise Bell,
19		Aaron & Carrie Boes, Richard & Linda Bollenbacher, Rob & Mary Chappell, Thomas &
20		Kathleen Fries, Leslie & Dennis Hackenburg, Jeffrey & DeeAnne Hamilton, Allen &

Q.3. Where do you and your family live in relation to the turbine sites planned for the
 Republic Wind facility?

3 A.3. My husband Gary Hoepf and I live on a parcel of about four acres located along and to 4 the west of State Route 19 between Township Roads 138 and 148 in Adams Township, 5 Seneca County. According to Republic Wind's application, our home and property are 6 located near a number of turbine sites. The attached Exhibit A is a map showing the 7 location of our property as a rose-colored square with yellow lines drawn between our 8 property and proposed Republic Wind turbine sites. The nine nearest proposed turbine 9 sites are shown as "+" symbols in red circles. The distance in feet between each of these 10 turbines and our property is shown next to each of these turbine sites.

11 Q.4. What recreational activities, if any, do you and your family enjoy in your yard?

A.4. My husband and I have a pool in our backyard and we like to socialize with our children,
grandchildren, and friends at the pool and in the yard. Birds and bats are common in our
yard, and we enjoy watching them. Bats live in our two barns. We erected bluebird boxes
in our yard for nesting. We have a bird bath in the yard. We have planted about 100 trees
that attract birds and other wildlife.

Q.5. Do you have any concerns about the potential impact of the Republic Wind project
on the enjoyment of your yard?

A.5. Yes. In particular, my husband and I are concerned that noise and shadow flicker from
the wind turbines may spoil the enjoyment of our yard and annoy us in the house. The
Exhibit B attached hereto depicts the view of a sunset from our backyard near the pool.
We are concerned that any wind turbine(s) located between our yard and the setting sun

as depicted in this photograph could cause shadow flicker on our property.

# Q.6. Have you seen any Bald Eagle nests in or near the Project Area for the Republic Wind project?

3 A.6. Yes.

#### 4 Q.7. Where have you seen these Bald Eagle nests?

A.7. I have seen six eagle nests. On Exhibit C attached hereto, I have marked the locations of
these eagle sightings on a copy of Figure 2 of Exhibit E of Republic Wind's application
dated December 26, 2018. On Exhibit C, a handwritten "X" inside a circle marks the
location of each eagle nest I saw.

9 On about a dozen occasions in 2019, I viewed a Bald Eagle nest on wooded land 10 owned Gary Weller located just west of State Route 18 and south of Township Road 138 11 within the blue outline of the Project Area shown on Exhibit C. I have seen Bald Eagles 12 near this nest on at least six of these occasions, including one on April 23, 2019, when I 13 saw a mature Bald Eagle sitting on the nest. Most of these eagles were adults (i.e., eagles 14 with white heads), including a Bald Eagle that flew out of this nest during one of my 15 visits. A photograph I took of this nest on October 24, 2019 is attached as Exhibit D. 16 On October 24, 2019, I saw Bald Eagles at three eagle nests northwest of the Republic Wind Project Area. One of these nests is located at State Route 19 north of 17 18 Green Springs, Ohio. I saw one mature Bald Eagle at that nest. The location of this nest 19 is not marked on Exhibit C. Another nest is located to the west of North County Road 51 20 between its intersections with East Township Roads 164 and 166. Its location is marked 21 with an "X" inside a circle on Exhibit C. I saw two mature Bald Eagles at that nest.

Another nest is located near the intersection of North Township Road 133 and East

County Road 51. Its location is marked with an "X" inside a circle on Exhibit C. I saw
 two mature Bald Eagles at that nest.

3		On October 25, 2019, I saw Bald Eagles at two eagle nests west and southwest of
4		the Republic Wind Project Area. One of these nests is located on the west side of County
5		Road 33 between its intersections with East Township Roads 144 and 148. Its location is
6		marked with an "X" inside a circle on Exhibit C. I saw two mature and two immature
7		Bald Eagles near this nest. Another nest is located near State Route 101. On Exhibit C,
8		its location is marked with an "X" inside a circle over the word "Project" in the lower left
9		hand corner of the map. I saw two mature Bald Eagles there.
10	Q.7.	Besides the Bald Eagles you described in your previous answer, have you seen any
11		other Bald Eagles in the Project Area for the Republic Wind project?
12	A.7.	Yes.
13	Q.8.	Where have you seen these Bald Eagles?
14	A.8.	On October 25, 2019, I saw two mature Bald Eagles in a field about 200 yards from the
15		nest in Gary Weller's woods. My photograph of these eagles is attached as Exhibit E.
16		On October 25, 2019, I saw one immature and two mature Bald Eagles flying to
17		the southeast of my house.
18		On October 24, 2019, I saw a mature Bald Eagle in a tree in a field about 300
19		yards from this nest. My photograph of this eagle is attached as Exhibit F.
20		On October 24, 2019, Crystal Hoepf and I saw a mature Bald Eagle flying above
21		an open area to the southeast of East County Road 38 and North Township Road 175.
22		On October 24, 2019, I saw an immature Bald Eagle perched in a tree just south
23		of my property along State Route 19.

1		On August 17, 2019, I saw an adult Bald Eagle sitting in a field within the
2		Republic Wind Project Area along Township Road 138 east of State Route 19 near our
3		house as I was riding in a pickup truck on Township Road 138.
4		On or around April 30, 2019, I saw an immature Bald Eagle sitting in tree behind
5		a cemetery southeast of the intersection of State Route 19 and North State Route 101.
6		On May 10, 2019, I saw two mature Bald Eagles perched in a tree southeast of
7		State Route 18 and Township Road 138.
8		On May 11, 2019, I saw one mature Bald Eagle in a tree at the same location as
9		the eagle I saw on May 10, 2019, and another mature Bald Eagle sitting on the ground in
10		a field northeast of the intersection of State Route 18 and Township Road 138.
11		On October 29, 2018, I saw three Bald Eagles flying over a field within the
12		Republic Wind Project Area at the northeast corner of Township Road 148 and Township
13		Road 175 as I was driving on Township Road 175.
14		In the summer of 2018, I saw a mature Bald Eagle on the berm of State Route 19
15		just south of my land within the Project Area.
16		On or around April 9, 2018, I saw a Bald Eagle with a white head eating a
17		raccoon in a field owned by Gary Baldosser (or his company) across from my house on
18		the east side of State Route 19, within the Project Area.
19		The locations at which I saw these Bald Eagles and other Bald Eagles are marked
20		with "X"s on Exhibit C.
21	Q.9.	Do you watch birds in any other places besides your yard?

A.9. Yes. My husband and I have been birdwatching in Magee Marsh, East Harbor State
 Park, Maumee Bay State Park, Garlo Heritage Nature Preserve, Howard Collier Nature


3 Preserve, and Steyer Nature Preserve.


