Dear Neighbor,

You are receiving this letter because you own property or live in the area that's part of AEP Ohio's Sardinia Area Improvements Project. I'm writing to provide an update about the project, which involves building 3.8 miles of new 138-kilovolt (kV) power line. The line travels through Eagle Township in Brown County, east of Sardinia.

AEP Ohio Transmission Company, Inc. filed the enclosed amendment with the Ohio Power Siting Board (OPSB) on October 24, 2019 that includes minor changes to the approved application we submitted for the project on April 30, 2018. Changes include removing one structure and adjusting the location of four structures near the Sardinia Substation making a slight route change.

Since submitting the original application, the following events have taken place leading up to the recently filed amendment:

- The OPSB certified the application as complete on June 29, 2018 based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1).
- The OPSB approved the application on February 21, 2019 under Case No. 18-0033-EL-BTX.
- The OPSB issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred power line route.
- AEP Ohio proposed adjustments to the approved power line route.


This power line project provides an additional power source to the area's electric transmission system and improves reliability.
