Upon review, the F684 Road Improvement Project in Elmwood Place should be exempt from requiring a Hamilton County Earthwork Permit. The total area disturbed is below 1 acre. The use of the construction matting on the unpaved areas will limit the disturbance. On figure 4.03, the installation of a gravel pad and adding gravel to the existing road also constitute a minor disturbance.

The project will still need to follow the requirements of the Hamilton County Earthwork Regulations even though an Earthwork Permit is not needed.
